Hi Dan,

Just wanted to update you on AGE. After my last email we have not heard anything from AGE and therefore, they at this point do not have permission to enter on our property. I am in the process of making arrangements to do our own testing. What is outlined in the Order is more extensive than what we previously have done in some ways but in the past we also completed testing to determine whether bacteroides were human or non-human which we feel is important.

The quote I received from our consultant for the testing that the Ministry has ordered plus the additional testing for human bacteroides is approximately \$12 000 per testing event. This compares to approximately \$4000 we have paid in the past. I am not an expert in this field, when it comes to student safety will the added testing provide any additional information?

Hi Dan,

Site access has been a contentious issue since the issuing of the first Abatement Order (November 23, 2017). AGE requested access to install the fence and signage on December 1, 2017 and was informed that SD43 had already installed them. Documentation of the SD 43 fencing and signage was reviewed with MOE, and was determined by MOE to be insufficient, as it was plastic snow fencing and paper signs.

Permission to install the MOE required fencing and signage was granted by SD 43 on December 22, 2017. The three week delay was caused by administrative processes required by SD 43. These included CUPE permission for subcontractor to work on school grounds, confirmation of insurance requirements of AGE, four revisions to a license agreement, and the limited availability and holiday schedules of SD 43 staff.

The SD 43 required licensing agreement granted permission for AGE to install the fences for a six month period; it also required AGE to pay to \$11,0000 to SD 43. The rationale and or documentation for the payment was never provided by SD 43. Regardless of this the \$11,000 payment was made as means of ensuring AGE was compliant with the order.

On January 18, 2018 AGE received legal correspondence demanding that GST also be paid on the \$11,000. As no invoice was provided, AGE did not pay the GST. On August 30, 2018 AGE received additional legal correspondence that the license agreement had expired and that the extension required an additional payment of \$9,000. Given the continued ambiguity and expense of the license agreements AGE has declined to pay. Because of this, SD 43 will not grant access to the SD 43 lands.

I have a attached the licensing agreements and legal correspondences here, and can supply the email chains regarding initial delay in fencing installations upon your request.
