For your information, Anmore Council passed the following resolution at a closed meeting on Wednesday, November 7th:

“That Council direct staff to make application to the Greater Vancouver Sewerage & Drainage District Board for the Village of Anmore to become a member of the Greater Vancouver Sewerage & Drainage District in order to facilitate the 51 units at Anmore Green Estates Strata being connected to the regional sewer system at their sole expense”

The Village is still working on developing a timeline for the required approvals. I have a meetings with both Metro Vancouver and the City of Port Moody this week and will provide an update as soon as possible.

One thing that came out of yesterday's briefing was the direction to obtain a more specific response to my recent inquiry regarding the specific processes and estimated timelines required to facilitate the connection. For instance, Jason indicated that step one is the OCP amendment so a description of that process , public consultation involved and estimated time to completion.

Jason also mentioned the negotiation of a pipe agreement with Port Moody so any detail that you can provide regarding that process including estimated time to complete or if it could be done in concert with the OCP amendment.

Obtaining membership in the GVS&DD was also mentioned, but perhaps an estimate of the time involved in completing that process? For instance, I understand that a servicing study must be completed prior to membership. Would this commence after OCP amendment, during, commensurate with the pipe agreement negotiations and how long would this likely take?

To date you've indicated 6 months to connection. What my executive is looking for is a little more meat on those bones regarding the specific processes.
