MINUTES FOR JULY 12, 2019

SWRI LIBRARY - 6220 CULEBRA ROAD
SAN ANTONIO, TX 78238

I. CALL MEETING TO ORDER:

The meeting was called to order at approximately 10:12 a.m. by the LEPC Vice Chairman Walt Daugherty. Those in attendance introduced themselves.

II. ATTENDANCE:

III. CITIZENS TO BE HEARD:

IV. APPROVAL OF MINUTES:

Minutes of the June meeting were not available at this time, review and approval was postponed.

V. FINANCIAL REPORT:

Paul Barrera reported on the financial statement John Hageman created using a bank statement ending June 24, 2019. To summarize activity, there was approximately \$50 in interest/dividends income; no contributions and one check was written to Emily Thompson for repayment of a luncheon. The current balance is \$53507.00.

VI. OLD BUSINESS:

VII. COMMITTEE REPORTS:

a. HazMat Watchdog Committee:

William Johnston, BCOEM, reported on an aqueous ammonia (19%) spill that occurred off of 181. Two trucks had rear-ended and the straps holding the totes down failed, spilling approximately 2500 pounds of aqueous ammonia. One first responder was taken to the hospital for inhalation of fumes. BCOEM reports that all of the placards were properly displayed, and the driver presented the MSDS to them upon arrival. SWS remediated the scene.

Glenn Frost, SAFDHazmat, reported the incidents that occurred during the months of May and June. There was a gas leak near Rebecca Creek Distillery. There was a sulfur dioxide leak in May at a SAWs facility. Code Compliance requested assistance at a facility located off Pinn Road that was leaking fluids. There were several 18-wheeler spills/punctured saddle tanks. There were several gas leaks from contractors drilling near gas lines. There was one white powder run. There was a reported liquid salt fire, but it was really machinery that had caught on fire.

Abe Gallegos, CPS, reported one spill from a 30-gallon transformer into a nearby creek. The fluid was non-detect for PCPs. The spill was reported to TCEQ and EPA.

b. Training Committee:

Walt Daugherty advised that the Texas A&M Fire Municipal and Industrial School will occur in July.

William Johnston provided information related to the classes/presentations he attended at the International Haz-Mat Conference in June in Baltimore.

c. Facility Operator Liaison Committee (RMP/Tier II):

d. Exercise Committee:

JBSA will have an Active Shooter exercise later in the year, and an update will be provided with details as soon as they become available.

e. Membership Committee:

Walt Daugherty passed around a revised Form 151 during the meeting for members to see. This form will be presented to Judge Wolf for signature asap.

g. THIRA Annex Q:

h. Community Outreach Committee:

Damon Shodrock, Aegis, reported that this is a quiet time for Community Outreach. The LEPC was invited to an event on September 10, but he will be unable to attend. Damon would like to apply for Flint Hills Resources' Helping Heroes program to purchase a fire extinguisher training kit for outreach. These kits are a big hit with kids, and he would like the LEPC to have its own dedicated kit. It was recommended that the LEPC also look into educational kits on household chemical safety.

VIII. NEW BUSINESS:

The committee was reminded that Bexar County LEPC awarded funding for three positions for the recent training that occurred in Baltimore. One position was for BCOEM, one position for SAFD, and one position for Guadacoma. This year, SAFD allowed BCOEM to send an additional person in their place. A mix up occurred between BCOEM and Guadacoma. BCOEM was under the impression that Guadacoma was not attending. BCOEM sent an additional BCOEM member in Guadacoma's place, however, Guadacoma was able to attend. A motion was made by Walt Daugherty to extend an additional \$2000.00 for funding for the fourth position. The motion was seconded by Abe Gallegos. Motion passed. BCOEM reported that in the future, they will not be sending any members in another department's place.

IX. ANNOUNCEMENTS:

Victor with OSHA requested 15-20 minutes at the next meeting to present on OSHA emergency response capabilities. He requested to be added to August's Agenda.

X. ADJOURNMENT:

The meeting was adjourned at approximately 11:20 a.m. The next LEPC meeting is scheduled for Friday, August 9, 2019 starting at 10:00 a.m. at the Southwest Research Institute Library 4th Floor.


