# MINUTES FOR DECEMBER 14, 2018

# I. CALL MEETING TO ORDER:

#### VII. COMMITTEE REPORTS:

#### a. HazMat Watchdog Committee:

William Johnston, Bexar County HazMat reported a few diesel spills in Bexar Co, all were below the reporting limit. There was a gas line rupture that shut down Southside ISD. CPS had to stop the leak. They were unsure how it started, but there was a burned down dumpster on top of the site. They think it may have been started by a blown down powerline.

Glen Frost, SAFD reported 7 incidents. 3 diesel spills, a truck carrying a thick lubricant was overturned on the Fine Silver turn, one envelope containing benzodiazepine was sent to a residence, one report of granules on an envelope, but no granules were found, and one spill of 50 gallons of Naphtha into the San Antonio River.

#### b. Training Committee:

William Johnston, Bexar County HazMat reported that he is working on developing the 2019 Training schedule. He is also working on developing training games for firefighter personnel.

#### c. Facility Operator Liaison Committee (RMP/Tier II):

Willie Davis, HEB reported that TCEQ is offering training on the new process of submitting Tier 2s. Training was held on Dec 12 and 13 in San Antonio. Additional trainings will be offered in other parts of the state. <u>https://www.tceq.texas.gov/permitting/tier2/training.html</u>
