Minutes for January 8, 2016

OPENING:

I. Call to Order:

The meeting was called to order at approximately 10:20 a.m. by the LEPC Chair Harold Lovejoy. Those in attendance introduced themselves.

IV. Approval of Minutes:

Minutes of the November 13, 2015 and December 11, 2015 meetings were distributed to attendees for review.

a. <u>HazMat Watchdog Committee:</u> (Mike Parsons, William Johnston, Patrick Lewis, Emily Thompson, Ronnie Hernandez, Johnathan Jones, Charlie Metzger)

Hal Lovejoy mentioned that Mike Parsons, who was unable to attend this meeting, is planning to provide an annual report of incidents and more information on the mapping system during next month's meeting.

William Johnston, BCOEM, advised that the past month has been fairly uneventful. Basically responding to the typical 30-50 gallon diesel spills.

Ronnie Hernandez, SARA, advised on an accident at La Cantera & IH-10 at 3am January 5, 2016 where an 18-wheeler carrying milk had an accident and spilled milk into Leon Creek. Spill was abated, and creek bed cleaned.

Damon Shadrock, Calumet, provided an update on the fire that occurred at their facility on December 5, 2015. There was an internal leak of heating oil, and calculations said that there was a release of 140 pounds of Dowtherm A. That met the requirements to be a reportable quantity. Equipment is back online.

b. <u>Training Committee:</u> (Walt Daugherty, Patrick Lewis, William Johnston, Stan Moczgmba)

Roger Pollok, Metro Health, advised there will be a High Consequence Infectious Disease Response Workshop in New Braunfels on January 20-22, 2016 hosted by Texas Department of State Health Services (DSHS).

William Johnston, BCOEM, advised that there will be an Oil Spill Containment, Protection, and Recovery Tactics (Inland Water) course on February 26-28, 2016 at the EOC. The course location may change. Course is taught by TEEX, and you can register for it online at www.preparingtexas.org.

Dr. Bauer mentioned that he is still working on getting advanced life support courses, and a basic disaster life support course organized.

STRAC annual conference is April 28-29, 2016. The four tracts will be Disaster, Trauma, Cardiac, and Stroke. It will be held downtown San Antonio this year.

William Johnston said he would like to arrange to have another CAMEO class, if there is enough interest. Charlie Metzger kindly provided the purpose and capabilities of CAMEO. The software and training are free.

Hal Lovejoy advised that Tier2 is around the corner and he is starting to get inquiries and updates.

Greg Batts advised that the City of San Antonio has a new rule requiring some facilities, which store any chemical that may emit a fugitive emission that causes ozone depletion, to pay \$200 per year. It was said that the goal is to build a registry of facilities, and gather information to help understand emissions related to nonattainment.

Roger Pollok mentioned that on March 16, 2016 there is a Communicable Disease Response Plan Exercise for SA International Airport, being held at the EOC. The exercise design has a plane coming in to the airport with an infected person onboard.

State of Texas Preventive Radiological/Nuclear Detection **Program Development**

Preventing radiological and nuclear terrorism requires the ability to detect and interdict nuclear materials before they can be misused.

Will Sector Working A State-level multi-discipline, multi-agency Nuclear Sector Working Group has been formed to develop systematic and coordinated plans for detecting, interdicting, and assessing radiological and nuclear encounters within the State of Texas and responding to a possible or actual radiological/nuclear threat or incident.

A series of activities has been organized through the Summer of 2016 to facilitate the creation of a State-level preventive radiological/nuclear detection (PRND) gap assessment, concept of operations, and implementation & sustainment strategy. State and Local agencies that have a role in the detection and resolution of radiation incidents are invited to participate, including:

- Law Enforcement / SWAT
- Bomb Squad / EOD
- Commercial Vehicle Inspection · Maritime/port security and law enforcement
- Fire / HAZMAT Fusion Centers
- Environmental Protection
- Public Health
- State Radiation Control

PRND Program Development Goals

- Improve awareness, prevention, protection, and security of both government agencies and private businesses through enhanced radiological/nuclear planning, training and response;
- Identify, develop and support best practices in preventive radiological/nuclear detection;
- Coordinate, provide, and inform state and local agencies and organizations of educational and training opportunities;
- Provide guidance to state and local agencies and organizations on the vision, strategies. deliverables, tools and initiatives to develop best-practice radiological/nuclear prevention
- Assist in the development, coordination, and conduct of readiness exercises integrating radiological/nuclear prevention and response scenarios in Texas; and
- Facilitate radiological/nuclear information sharing among state, regional and local law enforcement, public safety, and partner agencies.

The State of Texas PRND Program development effort supports the 2015-2020 Texas Homeland Security Strategic Plan strategic goals and objectives to reduce the risk of chemical, biological, radiological, nuclear, and high-yield explosives (CBRNE) incidents by enhancing control and early detection capabilities.

State of Texas Preventive Radiological/Nuclear Detection Program Development

The Nuclear Sector Working Group (NSWG) is an organization of public and private critical infrastructure stakeholders, working jointly in continuing efforts to share information, identify and address operational concerns, and to increase the security and resiliency of Texas' critical infrastructure in their sector. The NSWG, via the Texas Office of Homeland Security, has obtained assistance from the Department of Homeland Security Domestic Nuclear Detection Office (DNDO) to support PRND program development efforts.

The Texas Department of State Health Services and Texas Commission on Environmental Quality, with support from the Texas Office of Homeland Security, will co-lead the NSWG and PRND program development effort the inaugural year.
