MINUTES FOR JANUARY 11, 2019

I. CALL MEETING TO ORDER:

The meeting was called to order at approximately 10:10 a.m. by the LEPC Chairman Harold Lovejoy. Those in attendance introduced themselves.

IV. <u>APPROVAL OF MINUTES:</u>

Minutes from the November 9, 2018 and December 14, 2018 meetings were distributed to attendees for review. Chairman Lovejoy asked if there were any revisions the minutes, and none were provided.

A motion was made by John Hageman to accept the May meeting's minutes as written; the motion was seconded by Willie Davis. Motion was approved.

A motion was made by Damon Shodrock to accept the June meeting's minutes as written; the motion was seconded by Willie Davis. Motion was approved.

V. FINANCIAL REPORT:

John Hageman reported on the financial statement he created using a bank statement ending December 24, 2018. A copy of the full financial report was emailed out and is attached. To summarize, there was approximately \$39 in interest/dividends income; no contributions; and one check written for HOTZONE expense reimbursement for \$30. The current balance as of December 24, 2018 was \$60,325.40.

VI. OLD BUSINESS:

John Hageman briefed the committee about last month's LEPC trailer discussion. Bexar County has agreed to keep the LEPC's trailer at their facility. After additional discussion, John Hageman made the motion to transfer ownership of the trailer to Bexar County. Motion was seconded by Willie Davis. Motion was approved.

VII. COMMITTEE REPORTS:

a. <u>HazMat Watchdog Committee:</u>

Billy Johnston, BCOEM, on December 23, 2018 Superior silica sand pit had a structure fire. Two 55-gallon drums of oil were affected. Plant remediated their site.

On January 2, 2019 BCOEM was called concerning a suspicious package (letter) in Jourdanton. FBI was on the scene, too. Air monitoring conducted. No threat found.

On January 11, 2019 there was an excavator fire by Kinder Parkway. Approximately 70-gallons of hydraulic fluid and 70-gallons of Diesel were spilled.

Patrick Lewis advised that CESO Hazmat has merged with Guadacoma Hazmat. Increased response area with more assets available.

b. <u>Training Committee:</u>

Patrick Lewis advised that there will be a Pro Board Certified HazMat Technician class February 18-22, 2019 at Live Oak Fire Department.

Steven Ruston, SAFD Hazmat, advised on multiple trainings that they have planned over the next couple months.

Billy Johnston noted that some training has been moved to in-house training, cancelled, or postponed due to the government shut-down.

William McCarson, CPS, asked if there was interest in information related to responding to substation fires. It was suggested to have a presentation during a LEPC meeting.

c. Facility Operator Liaison Committee (RMP/Tier II):

Hal Lovejoy reminded that the Tier 2 program in Texas has changed and TCEQ is hosting training for the new Tier II reporting system. Registration is available online at: https://www.tceq.texas.gov/permitting/tier2/training.html

William McCarson, CPS, gave an early notice that on November 13-14, 2019 CPS will conduct a Grid-X exercise, simulating cyber attacks.
