Minutes for November 13, 2015

# **OPENING:**

# I. Call to Order:

The meeting was called to order at approximately 10:10 a.m. by the LEPC Chair Harold Lovejoy. Those in attendance introduced themselves.

# IV. Approval of Minutes:

Minutes of the October 9, 2015 meeting were distributed to attendees.

Walt Daugherty made a motion to accept the minutes as written; the motion was seconded by Mike Broeker. Motion was approved.

#### V. Financial Report:

John Hageman provided the information on the financial statement he created as of October 24, 2015. A copy of the full financial report was emailed out and is attached.

To summarize using current balances John received today, the outstanding savings balance is \$7903.55, and checking balance is \$14,851.28. As of today, the contribution check from Randy Grimes on behalf of Flint Hills – Kock Co. for \$3000.00 has been deposited, Bexar Metro 911 check for \$12,450 was deposited, and the checks from Schertz and Terrell Hills FD have cleared.

John Hageman stated that all 2015 A&M fire training school reimbursement checks have cleared, and he announced that he received a contribution check from Willie Davis on behalf of HEB for \$1000.00.

#### VI. Old Business:

Mike Broeker commented on the October 6, 2015 Airshow exercise. He stated that the exercise was successful overall, but some internal issues were found. Additionally, the airshow on October 31 – November 1, 2015 went well.

#### VII. Committee Reports:

Mike Parsons, SAFD Hazmat, presented an incident map of their runs since August. Mike discussed each incident as he highlighted them on the map. Majority of the incidents were diesel responses. Mike will look into having all of the incidents from this year added to a map for the next meeting.

b. <u>Training Committee:</u> (Walt Daugherty, Patrick Lewis, William Johnston, Stan Moczgmba)

Walt Daugherty advised that he will apply to Bexar Metro 911 for next year's funding of \$16,000 right after the 1<sup>st</sup> of the calendar year.

Henry Gonzalez, NuStar, mentioned that he obtained information regarding millions of dollars that is available for first responder grants relating to pipelines and terminals, and suggests that anyone interested should look into it. Dr. Bauer asked if there is any interest in offering advanced life support courses. Mike Parsons said that people have inquired about them and there is interest. Dr. Bauer said he will work on renewing his trainer certification and get back with Dr. Fernandez. The courses have been held at the EOC in the past. Funding is needed to cover course costs.

Mike Parsons noted that STRAC recently had their Annual Decon Rodeo and the SAFD assisted and evaluated. He said that the training was good, and received positive evaluations. There's obvious improvement over the years.

Mike Parsons advised on the DHS funded Crude by Rail Emergency Response class he recently attended in Pueblo, CO.

Patrick Lewis stated that HOTZONE seemed to be well received this year. He is still trying to reconcile hotel receipts. Some responders had to return early due to rain and flooding.

Ronnie Hernandez, SARA, advised on their emergency spill exercise conducted on November 12, 2015 involving the San Antonio River at US Hwy 281 & Grayson Street. Exercise started at 10 am, and the debriefing meeting followed the conclusion of the exercise. Calumet, SARA, SAFD Hazmat, SAPD, and TCI participated. Evaluators noted that communication among different agencies was good and overall the exercise went well. Getting the booms across the river is something to work on.

Veronica Williams, SAWS, mentioned that there will be a chemical exercise on December 7, 2015 at Dos Rios with SAFD. Additionally, they will be working with SAFD (and hopefully Bexar County & Leon Valley) and perform field visits of the SAWS sites.

Mike Broeker advised that JBSA will be conducting a table-top Antiterrorism, Force Protection Condition, and CBERNE exercise on December 17, 2015. Planning for only military involvement.

# Impersonation of First Responders and Military

The Department of Homeland Security (DHS) recently released a fact sheet "Impersonation of First Responders" (PDF, 275 Kb). The 2-page brief cautions of the possibility of terrorists using the public trust of fire, EMS, and law enforcement personnel to their advantage by donning uniforms and using emergency equipment and vehicles to help them carry out attacks.

This method has been used successfully overseas, and thwarted plots in France and Belgium this year show the interest in using this scheme is still real. Emergency responders can help ensure they are not successful by utilizing the following security steps:

- Install anti-theft or keyless entry devices on all apparatus;
- · Use vehicle tracking systems;
- Install recorded video surveillance systems on all vehicle parking lots;
- · Report all stolen or missing uniforms, credentials, and insignia;
- Be able to quickly identify a cloned versus a legitimate vehicle or uniform.

The public accepts the presence of emergency workers without a second look, enabling terrorists or extremists impersonating first responders to access areas they normally wouldn't be allowed in. Even if the uniform is generic – no department patch, fake badge – if they look like the real thing, people take their authenticity for granted.

# **Codes Must Account for Classroom Barricades**

In April, we wrote that the <u>National Fire Protection Association (NFPA)</u> was studying life safety code enforcement and school safety measures in the age of active shooter events. The issues concerned locks and other security measures in place to protect building occupants from assailants and how they would affect life safety and fire codes. Current codes do not truly address this issue.

The final report from the December 2014 meeting was published in May and identified priorities in changes to regulatory codes including: addressing conflicts between security and safety; enabling code exceptions for lockdown events; and developing new door-locking procedures and technologies.

The InfoGram is distributed weekly to provide members of the Emergency Services Sector with information concerning the protection of their critical infrastructures.

The process to change the codes is underway and will likely be made in the next term. The NFPA states "security is in addition to the other building and operational elements that help to keep the educational environment safe," and stresses the role first responders play in coordination and cooperation. They also stress security itself should not be seen as a substitute for overall life safety measures.

# **Justice: New Office Focuses on Domestic Terrorism**

More Americans have died from attacks carried out by domestic extremists in the past few years than by international terrorist groups. Despite foreign terrorism taking the lead after the September 11th attacks, focus is shifting back to domestic terrorism and extremism, and the Justice Department created a new office to focus on the issue.

"The Domestic Terrorism Council will assist federal prosecutors nationwide who are working on domestic terrorism cases," stated a Department of Justice official. The office will look for legal gaps that need closing in order to address these threats while coordinating prosecution of domestic terrorists, as it differs from the way foreign terrorists are prosecuted.

Most homegrown violent extremists and domestic terrorists fall into the categories of radical anti-government, racist, anarchist, and other extreme beliefs. Recent cases in this category include the racially-motivated church shooting in South Carolina and the targeted murders of two Las Vegas police officers last year by anti-government extremists.

The new office will work with the Domestic Terrorism Executive Committee. Originally created after the Oklahoma City bombing, it was disbanded after the September 11th attacks and revived in April 2015, the 20 year anniversary of Oklahoma City. Both offices will work to discuss insights from cases and trends.

# Impersonation of First Responders

First responders provide the first line of defense for nearly all critical infrastructure sectors and the general public during natural disasters and other physical emergencies. However, malicious actors, both international and domestic, seeking to exploit the public trust first responders have earned, have sought to impersonate first responders in order to do harm to the American people, exploit site vulnerabilities, or destroy critical infrastructure. Malicious actions include the acquisition of authentic or fraudulent uniforms, equipment, vehicles, and other items that may be associated with law enforcement, fire, and emergency services personnel. Therefore, it is imperative emergency services organizations maintain an awareness of the current threat environment and continue to remain vigilant.

Terrorist propaganda, from organizations such as the Islamic State of Iraq and the Levant (ISIL), encourage supporters to engage in local acts of violence. The following examples highlight that extremist propaganda is resonating with audiences in our homeland and that these types of events could extend to the first responder community.

- In February 2015, Federal Bureau of Investigation (FBI) arrested an individual indicating interest in joining the U.S. military to provide information on U.S. military operations against ISIL and potentially target law enforcement officers or U.S. soldiers.<sup>2</sup>
- In March 2015, the FBI arrested two Illinois residents for conspiring to provide material support and resources to ISIL and planning to use U.S. Army uniforms to enter and attack a local military facility.<sup>3</sup>

Highlighted threats of first responder impersonation internationally include:

- Belgian police raided a house in January 2015 and uncovered police uniforms, weapons, and fraudulent identification documents, raising concern that the suspects may have been seeking to impersonate law enforcement.<sup>4</sup>
- French authorities disrupted a potential terrorist plot in April 2015 after responding to a call at a residence in Paris. A subsequent search of the resident's vehicle and home turned up multiple firearms, ammunition, bulletproof vests, police armbands, notes on potential targets, and other suspicious items suggesting the individual may have been planning to attack a church.<sup>5</sup>

Serving and protecting the public requires Emergency Services personnel to maintain a high degree of vigilance to responder impersonation and the consequences that could occur if successfully exploited. Impersonation of a first responder presents not only a danger to public safety, but also a potential threat to the security of our homeland. Because homegrown violent extremists or terrorists may attempt to impersonate first responders through the acquisition of uniforms, equipment, or emergency vehicles, it is imperative that emergency services organizations continue to maintain threat awareness, report suspicious activity, educate personnel about information sharing resources, and utilize effective measures to prevent theft of emergency response vehicles and equipment.

# **Best Practices**

- Follow established suspicious activity reporting protocols.
- Coordinate information sharing activities with state and major urban area fusion centers.
- Maintain threat awareness by utilizing Federal, State, and local information sharing platforms.
- Routinely review organizational and facility physical security measures.
- Install within emergency vehicles a commercial anti-theft or keyless entry device, if possible.
- Institute use of an automatic vehicle locating/tracking system.
- Ensure emergency vehicle parking lots and maintenance facilities are under recorded video surveillance.
- Develop procedures to quickly identify a legitimately marked response vehicle from a cloned vehicle.
