- Steve Mayhew reported with reference to a letter from Neil Jolly regarding the future of bowls in the Bury league, he made some very valid points and some great ideas going forward.
- Finals day is not really viable going forward as its too restrictive on numbers and limits each club to 7 players.
 A 3 wood pairs competition was agreed by those present and would be limited to players pairing up with their own club colleagues. This of course would be the basis for the competition, but it was agreed that some flexibility could be consented in the event of someone dropping out on the day.

The competition would remain at Risby and could be played on 8-9 mats and would now include a £5 per player fee. There also would be the usual raffle and pound in the bucket etc.

The top team competition (Cooke Trophy) may be contested by each club nominating 1 pair to compete.

The date for the Pairs Competition was set for Sunday 18th May 2025.

The Bury Cup Competition will aim to finish earlier next year and to achieve this the preliminary and first rounds
will be completed by end of November, Quarters by end of January and the semis by end of March and the final
in April. All matches up to the final will be on a home and away basis and the first drawn team play at home
first

The Bury Cup final will now be held at a neutral venue decided by the committee closer to the time and played during the week.

An East v West champions final will follow.

- Michael Ashman commented that with 8 committee members how do we come to an agreement in a vote at 4
 votes each, it was decided that the chairman would have the casting vote in this instance.
- Steve Mayhew or I will be sending out an email to all clubs to update the contact details for the year ahead.
- Our website has not been updated much since before covid with only the score tables being filled in remotely by Steve. It was suggested that we need to add more content to include minutes of meetings and AGMs which has been missing over the past few years. Also, the Knockout cup tables and timelines and results too and a general update. Stuart Mcneil will contact Paul Daniels to find out the procedure and later the committee may decide to go it alone and create our own website as Paul has enough to do as we now have people of our own who are capable to do this.

Steve Mayhew has offered to carry on updating our scores in the usual way for the time being.
