# **Opinion: Vouchers not good for schools**

The unique feature of education in the United States is a public system that opens the door to every child.

This wasn't on the mind of the Arizona legislature recently as they successfully passed Senate Bill 1431 which will expand "empowerment scholarships" to virtually every student. This bill will create a tiered system of education that will separate based on privilege and wealth.

This separation will come in the form of vouchers or empowerment "scholarships" that can be



used for private school tuition.

Supporters of vouchers, whom I've yet to meet in rural Arizona, will tell you they will provide better choices for financially disadvantaged families with children attending poor or failing schools.

It's a scam – just the like the guy in Nigeria who will pay you to help him get money out of the country.

These "scholarships" will provide approximately \$5,000 to parents who want to send their child to a private or religious school. The average cost of for a high school student attending one of these schools is \$17,000 annually. A poor family receiving a scholarship would still have to

U.S. History in Context includes the following categories: African American Perspectives, American Colonies, Biographies, Court Cases and the Supreme Court, Economics, Events-Decades-Cultural Trends, Government Documents, Hispanic Americans, Native Americans, Political Constructs-Movements-Organizations, and Wars-Conflicts. Just one click brings up numerous topics within those categories.

You can search within the categories or you can search by browsing a preselected topic list of over 500 items. Some of those topics include: Alamo, ACLU, Crazy Horse, D-Day, Farmers' Movements, Great Depression, National Park Movement, Miranda vs. Arizona, Vietnam War plus many more.

At the top of the page will be a Featured Topic photograph bar, as well as Featured Video and Featured News links. Click on those items to expand them to get more information. The articles will include pictures, videos, links to other resources and citations for use in bibliographies. You can also search simply by typing your idea into a search box.

There is also a link to Curriculum Standards by state for educators or home school parents to use as reference points for their classes.

### New 'distracted driving' law

Attention drivers ~ Please put down your phones and listen to this: Clifton's Town Council adopted Ordinance 02-2017 on Thursday, April 13, 2017 banning the use of handheld phones and other devices that may distract a driver while operating a motor vehicle within Clifton's town limits. The ordinance will take effect 30 days from the April 13th adoption date.

There's more reason than ever now to get used to going hands free. Even handling your phone when you drive may get you a citation in Clifton and Governor Ducey has signed a state law that applies statewide in Arizona banning teens who are newly licensed or those with a learner permit from texting behind the wheel.

"All drivers" while within the "Town Limits" may only make and receive phone calls using "Hands-Free" technology, such as Bluetooth, or systems that are integrated within the vehicle. Also permitted are single-finger touch and swipe movements to devices that are mounted to the vehicle. If those options or equipment are not available, drivers should pull over to a safe location before using their hand-held devices.

A person violating the ordinance and is not involved in a motor vehicle accident is subject to a civil penalty of \$50 for the first violation, \$100 for the second and \$200 for the third. A person who violates the ordinance and is involved in a vehicle accident is subject to a civil penalty of a minimum amount of \$250.

There will a public relations pamphlet available to educate motorists about the new ordinance. In addition, the Clifton Police Department will soon be offering assistance in to help motorists learn how to use their hands-free equipment.




# **Takeaways from caregiver workshop**










### **Greenlee ranks high on health**

Greenlee County is ranked second (only Maricopa County is rated ahead of Greenlee County) in all of Arizona in terms of health outcomes.

And yet many services go unnoticed, and worse underused. So let's review some of the services provided through the Greenlee County Health Dept:

#### **Immunizations:**

(Call to make an appointment)

The Greenlee County Health Department contracts with the Arizona Department of Health Services to provide a full range of childhood (6 months -18 years) and adult (19 years and older) immunizations for residents of the county. (Must meet financial eligibility).This program is funded by the Federal Government.

### Family Planning Services:

(Call to make an appointment)

Services are primarily by appointment and include: information and counseling about contraceptive methods, physical examinations and follow-up, contraceptive supplies, diagnosis and treatment of minor gynecological problems, pregnancy testing and referrals to providers for OB/GYN services. Males/Females over the age of 14 years old are provided service on their own consent. Parental consent not needed. Services are confidential.

In our research we found that many rural communities are suffering similar challenges (loss of local banking services). This is what you as a resident or business owner need to know:

1. With the help of Supervisor Richard Lunt Greenlee County has successfully identified 2 potential bank service operators licensed in the state of Arizona to come to Duncan.

2. We need your help in 3 ways. 1.First be willing to open a savings and or checking account with the new institution. 2. If you have loans in other banks or credit unions be willing to consider moving those loans to the new banking services provider.

3. Put your support in writing. Write a letter on your business letterhead, personal letterhead or on a sheet of paper. Let the banking services community know you will support them once they open their doors in Duncan.

We have the support and backing from the Arizona Dept. of Financial Institutions (AZDFI). They know how difficult it has been for Duncan to be without a local banking services entity.

Our contact there is Tamilee Smull, the Division Manager for AZDFI. If our effort to gain a commitment from either of the current banking services providers that have expressed interest we have been sent a list of all licensed credit unions and banks in Arizona which could/would qualify to open a branch in Duncan.

cough up \$12,000 to attend one of these schools – if they had \$12,000 for private school tuition they wouldn't be ... poor.

However, if you're already planning to pay \$17,000 to send your child to a private school – the state general fund is now going to assist you to the tune of \$5,000.

That is \$5,000 in public tax dollars that will not be in the state general fund to restore public school funding, improve teacher salaries, buy computers or fix roofs. The legislation phases in scholarships at 5,000 students annually which mean 25 million dollars could be directed towards private schools in the first year.

#### **Tax dollars**


Parents have every right to send their child to a private school; however your tax dollars should not be funding that private education. The doors of private schools are not open to all students. Students apply – not all are chosen - for a variety of reasons that are often not public. Public tax dollars should support schools that are open to the public . . . every single child.

A pilot of this bill was already in place. A recent study published in the *Arizona Republic*, "Arizona taxpayer-funded vouchers benefiting students in more affluent areas" found the vast majority of families using this scholarship were from the communities of Scottsdale, Paradise Valley, Cave Creek, and Peoria. It would be nice to know how many poor students from those areas are being served.

#### **Dark money**

The path to success of this legislation was paved early in the election cycle when the American Federation for Children pumped 213,000 in dark money into key legislative races across Arizona. Don't be fooled by the name - The American Federation for Children seeks to divert public money to pay for private education – a key to dismantling public education.

Some of this dark money reached our local legislators. Representative Becky Nutt and Senator Gail Griffin who each received over \$9,000 in campaign funding from American Federation of Children both voted for this bill. Representative Drew Johns also voted for "yes" on this bill. It is difficult to



imagine that this legislation reflects the values or was a priority of parents in rural schools across our legislative district. I'm guessing they would rather have had their local school capital budgets, which have been slashed 85%, restored.

This is not the school system most of us attended. It is not the school system called for in the Arizona Constitution – uniform and equal. Nor is it the school system that made American unique to the world in almost every way.

# **Funding for economic development looking hopeful**

Early Monday morning (May 1), congressional appropriators released an omnibus spending bill for the remainder of fiscal year (FY) 2017. The bill, the Consolidated Appropriations Act of 2017, funds federal programs through September 30, 2017.

The House and Senate are expected to pass the package this week before the current short-term continuing resolution (CR) keeping programs operating expires May 5.

It is important to note that most funding to be formally appropriated has already spent since federal programs have been operating under a CR since the beginning of the current fiscal year on October 1, 2016.

There are five months remaining in FY2016, so programmatic increases over FY2016 levels will apply to remainder of the current fiscal year. FY2017 Funding for Key NADO Federal Agencies and Programs

#### **Economic Development Administration**

\$237 million for Economic Development Assistance Programs, \$15 million above the FY2016 level (specific programmatic funding is not yet available)

#### **USDA-Rural Development**

\$2.94 billion for Rural Development Program, \$166 million above the FY2016 enacted level

\$920 million for Business and Industry loans, level funding from last year

\$1.25 billion for rural water and waste program loans, level funding from last year

# Arizona unemployment rate drops to 5%

Arizona's seasonally adjusted unemployment rate decreased from 5.1% in February to 5.0% in March.

The U.S. seasonally adjusted unemployment rate decreased from 4.7% in February to 4.5% in March. A year ago, the Arizona seasonally adjusted rate was 5.4% and the U.S. rate was 5.0%

#### **Over the Month**

Arizona gained 8,800 Nonfarm jobs (0.3%) in March. This was less than the post-recessionary ('10-'16) average gain of 11,300 jobs. The Private Sector gained 11,200 jobs (0.5%).

Historically, ('10-'16) the Private Sector averages employment gains of 11,900 jobs in March.

Five of the eleven sectors posted gains. Gains were recorded in Leisure and Hospitality (9,400 jobs); Construction (3,500 jobs); Financial Activities (1,000 jobs); Information (200 jobs); and Other Services (100 jobs).

Over the month losses were seen in Education and Health Services (-100 jobs); Trade, Transportation, and Utilities (-500 jobs); Professional and Business Services (-1,100 jobs); Manufacturing (-1,300 jobs); and Government

(-2,400 jobs).

#### **Over the Year**

Arizona Nonfarm employment grew by 2.1% (56,000 jobs) over the year in March. The Private Sector accounted for 57,400 jobs (2.5%). Government employment decreased by 1,400 jobs in March.

Seven of the eleven sectors reported job gains and four had losses. The sectors with the largest gains included Leisure and Hospitality (19,500 jobs); Financial Activities (10,900 jobs); Education and Health Services (10,700 jobs); and Professional and Business Services (9,800 jobs).

Gains were also recorded for Trade, Transportation, and Utilities (4,700 jobs); Construction (3,700 jobs); and Manufacturing (1,600 jobs).


Job losses were reported in Natural Resources and Mining (-100 jobs); Information (-100 jobs); Government (-1,400 jobs); and Other Services (-3,300 jobs).
