**By the King,
A Royal Proclamation**

(to declare the De'Jure Kingdom of England 927-1707 in a State of Emergency)

Hear Ye Hear Ye,

King Clifford Jefferson (Geoffrey), ascendant and descendant from The House of Plantagenet, Heirs of John I, son of Henry II, son of Geoffrey V, Count of Anjou.

(Time Immemorial - Richard I 1189 A.D.)

To all Local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees. The English Church of England, now known as The Third Temple English Church of England, through its members as officers, hereby declared that all Agency, Officers and assignees lack personam jurisdiction over the King, and his heirs and successors, within the Kingdom of England. All courts lack personam jurisdiction against the personhood of a human being vs a legal person, who have separate legal personalities.

1.The legal personality of the personhood as presumed by the information on all instruments provided by all Local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, denotes to a legal entity such as an individual, company, or organization that has legal rights and obligations. They have the right to enter contracts, sue, and be sued, legally speaking (they can legally do most of the things a human can do, but they are clearly not human people in the ordinary sense, having no legal personality of their own.

2.The personhood showing on the instrument, provided by all Local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, denotes to a legal person, not a human being, though having the same information, belonging to the human being, being distinct of the legal person.

3. The information on the instrument, denoting to the personhood of the human being cannot be considered as evidence before a court, absent of a vital record, acknowledging the personhood of a human being.

4. The information on all instrument, provided by all Local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, denoting to personhood can only be construed by the court to be a legal person.

5. The agency within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, issuing such instruments, cannot be considered by a court, to establish personhood, of a human being.

6. The agency within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, do not receive, store or furnish information, for the purpose of personhood of human being, only legal persons.

7. The Agencies within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, do not receive, store or furnish information, for the purpose of personhood of human being, only legal persons.

8. The only Agency within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, that the law, allows to issue vital record of personhood of a human being, is the Hospital, in which the human being personhood was established by a vital record, establishing upon the face of that instrument, that the personhood of said person, is indeed a human being.

9. The Agency within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, can produce no evidence before the court, that shows for the record, that the agency has personam jurisdiction, to exercise such a venue, on a human being, by way of summons or order of any kind.

10. It is these foreign Agencies, within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, who are tenants, subtenants on the King's land, burden to prove that the King fits the description of a legal person, which is clearly a trademark practice violation pursuant to New Jersey Revised Statute title 56, within the Kingdom of England.

New Jersey Revised Statute title 16:1-28,4,30 and VA. Code 1-,200, 201,300,301, prohibits these agencies within your local Governments, such as Villages, Borough, Townships, Municipalities, Counties, including but not limited to their Agencies, Departments, Offices, including but not limited to their Officers, Agents and Assignees, of any court authority in lieu of these color of law venues, to establish personam jurisdiction over the king and his Heirs and Successors, within his own Kingdom, therefore you are ordered to dismiss all complaints, orders, summons of any kind, with confirmation via
