

SHARED CASES OF ALEX MURDAUGH AND CORY FLEMING: A RETROSPECTIVE

1. PINCKNEY FAMILY:

- A. **HAKEEM PINCKNEY** (AUGUST 22, 2009; CAR ACCIDENT VICTIM):
 - a. REPRESENTED BY **ALEX MURDAUGH** AT LEAST BY 2010; **INDICTED** FOR WRONGDOING THAT OCCURRED STARTING IN 2011

- B. **NATARSHA/NATASHA THOMAS** (AUGUST 22, 2009; CAR ACCIDENT VICTIM/COUSIN OF HAKEEM PINCKNEY):
 - a. REPRESENTED BY **ALEX MURDAUGH** APPROXIMATELY 2010; **INDICTED** FOR WRONGDOING THAT OCCURRED STARTING IN 2011

- C. **PAMELA PINCKNEY** (AUGUST 22, 2009; CAR ACCIDENT VICTIM/MOTHER OF HAKEEM PINCKNEY):
 - a. REPRESENTED BY **CORY FLEMING** AT LEAST BY 2012; **INDICTED** FOR WRONGDOING THAT OCCURRED IN 2012 & 2017

- D. **SHAQUARAH PINCKNEY** (AUGUST 22, 2009; CAR ACCIDENT VICTIM/SISTER OF HAKEEM PINCKNEY):
 - a. REPRESENTED BY ??

2. THE ESTATE OF BLONDELL GARY (JANUARY 31, 2012 AMBULANCE ACCIDENT VICTIM):

- A. THE ESTATE WAS REPRESENTED BY **ALEX MURDAUGH** FROM NOVEMBER 9, 2012 – JANUARY 10, 2020; **INDICTED** FOR WRONGDOING THAT OCCURRED IN 2019
- B. THREE (3) OF THE INDIVIDUAL DEFENDANTS IN THE COMPANION CASE WERE REPRESENTED BY **CORY FLEMING** FROM DECEMBER 11 – OCTOBER 15, 2018; **NO INDICTMENTS** FOR ANY WRONGDOING IN THIS CASE

3. **PAUL MURDAUGH** (MAY 29, 2017 MISDEMEANOR ALCOHOL CHARGE OF “PURCHASE OR POSSESSION OF BEER OR WINE BY A MINOR” BY THE DEPARTMENT OF NATURAL RESOURCES (DNR) IN BEAUFORT COUNTY; PAUL WAS 18 YEARS OLD):
 - A. PAUL WAS REPRESENTED JOINTLY BY **ALEX MURDAUGH** AND **CORY FLEMING** FROM APPROX. MAY 31, 2017 (when Paul was charged) THROUGH JULY 5, 2018 (when the charge was dismissed due to Paul’s completion of an alcohol diversion program); **NO INDICTMENTS** FOR ANY WRONGDOING IN THIS CASE

4. **THE ESTATE OF GLORIA SATTERFIELD** (FEBRUARY 2, 2018 SLIP AND FALL ACCIDENT VICTIM AT MOSELLE PROPERTY; DIED FEBRUARY 26, 2018 AS A RESULT OF THOSE INJURIES):
 - A. **ALEX MURDAUGH** WAS THE **DEFENDANT** FROM 2018 – 2021; **INDICTED** FOR WRONGDOING THAT OCCURRED STARTING IN 2018
 - B. THE ESTATE WAS REPRESENTED BY **CORY FLEMING** FROM 2018 – 2021; **INDICTED** FOR WRONGDOING THAT OCCURRED STARTING IN 2018

5. **CONNOR COOK** (FEBRUARY 24, 2019 BOAT CRASH VICTIM):
 - A. **ALEX MURDAUGH** IS THE **DEFENDANT** FROM 2019 – PRESENT; **ALEX MURDAUGH** IS BEING **SUED CIVILLY**; **NO INDICTMENTS** FOR ANY WRONGDOING IN THIS CASE
 - B. CONNOR COOK WAS REPRESENTED BY **CORY FLEMING** FOR A SHORT TIME STARTING ON FEBRUARY 25, 2019 – NOT LATER THAN SEPTEMBER 19, 2021 (WHEN JOE MCCULLOCH TOOK OVER); **NO INDICTMENTS** FOR ANY WRONGDOING IN THIS CASE
