- "AWAM" refers collectively to the Association for Women in Aviation Maintenance, AWAM Pacific Northwest Chapter 33, or any participating / collaborating / partnering AWAM Chapter.
- Participants refers to Members and Participants at least 18 years of age and to the legal guardian or parent of any Member or Participant under the age of 18. If Participant is an AWAM Pacific Northwest Chapter 33 Member this Release has been signed and is on file with their Chapter Application.
- Name refers to the activity participants first, given, nickname, or preferred name.
- Photo refers to any photograph, video, television, digital media or any similar future versions of such media that preserves an individual's likeness or image.

Liability Waiver

1. Participants assume full responsibility for damage to or loss of any personal belongings / property that may occur during any AWAM activities they join.
2. Participants signatures certify they are physically and mentally capable of participating in AWAM activities they join.
3. Participants acknowledge that participation in any AWAM activities is done so willingly and voluntarily.
4. Participants understand that participation in AWAM activities may involve the risk of harm.
5. Participants assume full responsibility for any and all injuries and any expenses related to such injuries sustained during any AWAM activities.
6. With knowledge of the potential risks involved, Participants must sign this waiver, releasing and discharging AWAM and all AWAM Board Members, officials, officers, employees, agents, volunteers or appointees, from any and all claims arising from participation in AWAM activities, except when such claims arise from the gross negligence or willful acts of the AWAM parties involved in the specific AWAM activity.

Emergency Medical Treatment

In the event of an injury in connection with any AWAM activity Participants agree that their sign-in signature* provides consent to emergency medical treatment provided by a licensed physician, paramedic or other medical provider. Such care may be given under any conditions necessary to preserve life, limb and /or wellbeing. Participants agree to hold all such medical providers rendering such emergency medical treatment harmless in connection with such efforts on Participants behalf. Participants understand and agree that the cost of any Medical Treatment provided will be at their own expense.

- * A parent or legal guardian must sign-in with each minor. Without a sign-in signature or prior arrangements the minor will not be allowed to participate.

Virtual Activity Consent

2. Participants acknowledge they are responsible for ensuring their environment is safe / free from obstructions.
3. Any offered exercises, training or other physical activities presented during a Virtual Activity require coordination, physical mobility and balance. Participants should not attempt any activities that are beyond their ability.
4. AWAM is not liable for any injuries or other damages suffered as a result of participation in any virtual activity.
5. By signing this release form Participants agree to waive any potential claim against AWAM related to any virtual activity.
