

ONLINE PRIVACY POLICY AGREEMENT

Rae of Hope Ministry, Inc. (Rae of Hope Ministry) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Rae of Hope Ministry, Inc. of our commitment and realization of our obligation not to meet, but to exceed, most existing privacy standards.

We the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point of time Rae of Hope Ministry, Inc. decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To better understand your needs and provide you with the services you have requested;
- To fulfill your legitimate interest in improving our services and products;
- To send you promotional emails containing information we think you may like when we have your consent to do so;
- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;
- To customize our website according to your online behavior and personal preferences.

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies and associations the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in the Policy.

Use of Information Collected

Rae of Hope Ministry, Inc. does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Rae of Hope Ministry, Inc. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <https://raeofhopeministry.org/>

Rae of Hope Ministry, Inc. may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

Rae of Hope Ministry, Inc. uses various third-party social media features including but not limited to [RAE of HOPE Ministry, INC | Eden NC | Facebook](#) and other interactive programs. These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and not within Rae of Hope Ministry, Inc.'s control.

Disclosure of Information

Rae of Hope Ministry, Inc. may not use or disclose the information provided by you except under the following circumstances:

- As necessary to provide services or products you have ordered;
- In other ways described in this Policy or to which you have otherwise consented;
- The aggregate with other information in such a way so that your identity cannot reasonably be determined;
- As required by law, or in response to a subpoena or search warrant;
- To outside auditors who have agreed to keep the information confidential;
- As necessary to enforce the Terms of Service;
- As necessary to maintain, safeguard and preserve all the rights and property of Rae of Hope Ministry, Inc.

Non-Marketing Purposes

Rae of Hope Ministry, Inc. greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in Rae of Hope Ministry, Inc. products and services). Children under the age of 13

Notice to European Union Users

Rae of Hope Ministry, Inc. operations are located primarily in the United States. If you provide information to us, the information will be transferred out of the European Union (EU) and sent to the United States. (The adequacy decision on the EU-US Privacy became operational on August 1, 2016. This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States for commercial purposes. It allows the free transfer of data to companies that are certified in the US under the Privacy Shield.) Security

Rae of Hope Ministry, Inc. takes precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline. Wherever we collect sensitive information (e.g credit card information), that information is encrypted and transmitted to us in a secure way. The computers and servers in which we store personally identifiable information are kept in a secure environment. This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user’s personal information under our control.

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users’ trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information.
