To the Parents of Third and Fourth Grade Students,

This letter explains that with your permission, your child is invited to participate in a one day a week Time-Release class taught by a Morgan County Weekday Religious Education Inc. teacher and assistant. Time-Released religious education has been approved of by both the United States Supreme Court and the Indiana General Assembly IC 20-33-2-19.

The two-year curriculum is offered to 3rd and 4th grade students and is non-denominational by design. The classes provide Bible education from both the Old and New Testaments using the King James version of scripture as the basis of the teaching materials.

For your child's safety, Weekday classroom doors are locked when children are on site. There are always at least two adults with the students. Weekday Religious Education Inc. uses bus transportation when necessary to ensure your child's safety.

We ask that you fill out the Request - Enrollment card included with this letter and have your child return the cards to their teacher. Your permission includes allowing the transportation of your child by bus to the Weekday Religious Education class site as needed. If you Do Not want your child's picture included in Weekday Religious Education's promotional electronic or printed media or in related newspaper articles please contact the teacher.
