11933 Magnolia Project Appeal Upheld

Shortly after Councilmember Krekorian (CD2) took office, he used a rarely-invoked section of the Charter (245) to move the hearing of the 11933 Magnolia project in Valley Village into the City Council’s jurisdiction. This effectively meant that the Council would now hear the community’s appeal of the Director’s determination previously approved by the Planning Commission. The City Council voted YES on the “245 Motion” which meant they took temporary jurisdiction for the next 21 days. The matter was immediately sent to their Planning and Land Use Management Committee (PLUM). On Tuesday, January 26th, the PLUM Committee motioned to sustain the appeal due to a finding that the traffic study was flawed. They sent their recommendation to approve our appeal to the City Council. On Friday, January 29th, the City Council voted affirmatively on the motion and the community’s appeal was sustained. The motion goes next to the Mayor for approval.

We are thankful to Paul Krekorian for addressing this issue as a top priority so quickly out of the gate. It was a baptism-by-fire scenario and the result was a win for his constituents, and, yes, for the wider community.

Nonetheless while this has gained a temporary respite, we will all be revisiting this project shortly, as the work is not completed. We now await the next action of the bank/developer. In addition to awaiting the property owner’s decision on how they want to proceed, we will also need to address the medium and larger issues that surrounded this project in the first place, as a project of this size and density should not be a future option. It is critical that the property be rezoned as should have been done in the 1990s.

The Board and Membership of the Valley Village Homeowners Association opposes SB1818 and the Los Angeles City Ordinance to implement SB1818. Therefore, we support the appeal (DIR-2008-1178-DB-SPP) regarding the SB1818 development located at 11933 Magnolia Boulevard, Valley Village.

- > Check chimneys, roofs and wall foundations for stability.
- > Secure water heater and appliances that could move enough to rupture utility lines.
- > Keep breakable and heavy objects on lower shelves.
- > Put latches on cabinet doors to keep them closed during shaking.
- > Keep flammable or hazardous liquids such as paints, pest sprays or cleaning products in cabinets or secured on lower shelves.
- > Maintain emergency food, water, medicine, first aid kit, tools and clothing.

A Letter from the President

Dear Neighbors:

I have got to tell you, I am worried. I am concerned with how our City runs its finances, how it budgets and how it views dealing with deficits. I may have to move back to Pennsylvania. Sanitation fees have tripled, LAUSD is talking about a parcel tax, our sales tax is 9.75% and now a proposed DWP rate increase is being proposed all in an effort to increase the City's revenue. (I hate calling it revenue – it's our tax dollars after all.)

I have long called for five year or longer forecasting of revenue and budgeting, yet our City continues to operate on a year-to-year basis. They handle each spending issue and crisis with a Band-Aid while approving generous wage packages for municipal and DWP employees.

It appears to me that our elected officials can't say no and can't figure out how to sacrifice when crisis hits. We are in crisis if you haven't noticed. City Controller Wendy Greuel announced the City will be out of cash to pay bills by May, but soon revised her projection by saying the payroll could be met only by digging deep into precious reserves. That would leave us vulnerable to emergencies and would adversely affect the city's credit rating.

I saw this coming and I think most of you did too. The economy began its decline in 2006. Instead of dealing with it, our Mayor did nothing. Now he has proposed a three day work week for non-revenue generating and non-emergency City employees. All in an effort to try and force the taxpayers of this City to accept higher fees and rates.

There is no good solution, but the solution can no longer be going back to the taxpayers for more money. We should be looking at ways to make City government more efficient and easier to deal with. We must make the hard decisions of what we can live without, at least for right now.

I have communicated to our Councilmembers, Paul Kerkorian and Paul Koretz, that the Valley Village Homeowners Association is not in favor of any additional taxes, fee increases or rate increases and those that support these increases will be hearing from the fine folks of Valley Village at the next election.

I think they heard us, DWP rate increases have been postponed for three months. The City Council has requested that the DWP better justify their reasoning for a rate increase. But the fight is far from over...

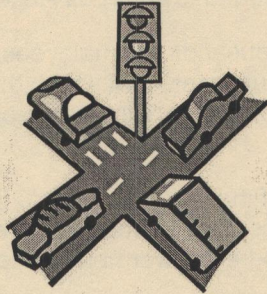
I encourage you to contact our elected officials also. Tell them how you feel about rate, tax and fee increases, City spending and budgeting. Whether you agree or disagree, we have to get a handle on our City finances. It's time to bite the bullet and stop the thinking that we (the taxpayers) are a bottomless wallet. This wallet is running dry and I don't really want to move back to Pennsylvania.

Additional Left Turn Lane

In an ongoing effort to mitigate the congestion from drivers attempting to maneuver from the Hollywood Freeway (170) southbound to the Ventura Freeway (101) westbound, the Los Angeles Department of Transportation is undertaking a study at Riverside Drive and Laurel Canyon to convert one of the westbound lanes of traffic into a second left-turn only lane. Several years ago the left turn only arrows were added at the intersection, but increasing westbound traffic at Laurel Canyon seeking to enter the freeway forces the existing left turn lane to create a daily backup of up to two city blocks during peak commute times. In reviewing the blueprints and discussing the proposed plans with the City's surveyor, implementation of a second left-turn lane to relieve the hazardous back-up traffic may be as early as this fall. Your Homeowners Association will keep you apprised of these developments.

Done with DONE

Neighborhood councils can't allow department's merger to stop them

AFTER years of ignoring the leaking boat that is the city's economic health, city leaders are now bailing like crazy to keep afloat in the face of a \$700 million dollar budget tsunami headed toward Los Angeles.

They're throwing over thousands of employees, including some from public safety. They're tossing out assets that weigh them down, like the zoo and its many denizens. They're even dumping entire city departments in the mad dash to avoid catastrophe.

Considering the scope of the budget shortfall, the Mayor and City Council have little choice. But their indiscriminate unloading shows just how little they think of the growing neighborhood empowerment movement.

For a measly \$2 million savings, Mayor Antonio Villaraigosa is proposing that the department that oversees the city's dozens of neighborhood councils be folded into the Community Development Department, losing about two dozen employees, including a general manager.

Don't worry, the Mayor said, this could be the beginning of a beautiful era for volunteerism and community fostering of NCs. Whether he meant it or was simply trying to spin a bad situation to his advantage, the mayor has a point. The dysfunctional Department of Neighborhood Empowerment, known around town as DONE, has done as much to obstruct the citizen panels as empower them.

Sure, it seems like a worrisome development. The mayor has also proposed the dismantling of such specialty departments as the Human Relations Commission and Cultural Affairs Department. Lumping DONE with these nonessential departments makes it seem as though the mayor and City Council see the rowdy and irreverent NCs as, well, nonessential to Los Angeles governance.

They couldn't be more wrong.

Still, some worry that sacrificing DONE is merely the first salvo by City Hall to crush the network of neighborhood panels that has been a thorn in the side of politicians since voters in 1999 endorsed the idea in the new charter.

But not everyone sees the loss of a historically troubled department as a terrible blow. In fact, some like Al Abrams, vice chairman of the Board of Neighborhood Commissions, see it as a way to escape from under the yoke of City Hall.

"I think most of the neighborhood councils will see this as a boost and giving them more freedom," Abrams said.

Abrams is right. Being thrown overboard isn't the ending. It may very well give the neighborhood councils the opportunity to swim free of City Hall politics and fully develop into the system of neighbor empowerment envisioned by voters for this new century.

How they fare in this reorganization is entirely up to the councils themselves. The neighborhood councils have never been a stronger force in Los Angeles than they are at the moment.

Despite the dysfunction at DONE over the years, the panels from West Hills to Westchester have given Angelenos a voice they never had before in city politics. Unless they allow it, a little thing like department consolidation shouldn't stop them.

On July 1, 2009, Paul Koretz took the oath of office to become the new Los Angeles Councilmember for the City's historic Fifth District.

Born in the San Fernando Valley, Paul was raised and attended school in the 5th District. He earned a bachelor's degree in history from UCLA where he was involved in volunteer endeavors aimed at improving society and helping others.

Serving on the staffs of Zev Yaroslavsky and Marvin Braude and as a Councilmember in the City of West Hollywood, Paul gained experience in city government. In 2000, he was elected to the California State Assembly, representing the 42nd Assembly District that includes much of the City of L.A.'s 5th District. He was reelected twice to his assembly post, serving the maximum-allowed three terms.

Paul hopes that the start of his council service in the City of Los Angeles also marks the start of a heightened commitment by the city to listen to the voice of the people, and to be ever-engaged in the life of our local neighborhoods.
