## **Mansionization-Plus**

In past Valley Villagers we reported on the growing trend of developers buying a Valley Village home and tearing it down to make way for a much larger home that uses most of the space on the lot. This has been commonly referred to as "Mansionization." Now this trend has spread to the apartment buildings in Valley Village. Many Village renters are receiving eviction notices for the apartments they occupy in smaller, older buildings to make way for larger, new condominium buildings.

When a developer buys a smaller, older structure and builds a new structure that maximizes the lot, whether a single family home or an apartment building, it seems like the same issue, Mansionization. But, there is one major difference: the overall effect on the community is more than just visual or blocking someone's backyard sunshine. Valley Village and City resources will be used at a greater rate, affecting everyone who lives here.

One large single-family home replacing one smaller single-family home does not have the same impact on the infrastructure as 24 condos standing where 12 apartments used to be. That means more children in the schools, more traffic on the streets, more water used, more sewage in the sewers and more strain on all public services and facilities.

This is happening in Valley Village. Four, side-by-side apartment buildings were just purchased by a developer on Magnolia between Colfax and Laurel Canyon. The same thing has happened on Albers Street and versions of it can be seen on Laurel Canyon near the corner of Huston. Mansionization? Or maybe we should call it Mansionization-Plus.

Of course there are two sides to every story --Owners have the right to sell their homes or their buildings. More homeowners mean more tax revenue for the City. These projects, whether they are singlefamily homes or multi-family condos, are being constructed legally under current building codes, regulations and the Valley Village Specific Plan. Los Angeles does need more housing. And sometimes progress is growth, where once stood walnut groves is now Valley Village.

City Councilmember Wendy Greuel, on April 24, 2006, held a meeting to discuss the growing concern of Valley Village renters. While no immediate solution was found at that meeting, our Councilmembers need to hear how you feel about this. 
