Demand For Accountability

"No taxation without representation" was one of the earliest outcries of protest by the American colonists. They should have said "no taxation without accountability." Representation is of little value unless there is accountability.

City Controller Laura Chick's audit report of the last trash fee hike drove this point home. Our "representatives" promised that hike would be used to hire one thousand police officers. Less than four hundred were actually hired. It has been suggested that the revenue was either mismanaged or the promise was disingenuous.

Now yet another trash fee increase has been approved by the City Council and supported by the Mayor. The purpose? To hire the remaining six hundred police officers who were promised with the first increase.

With the failure of the City to deliver on its promise, we are faced with more financial demands on the November ballot.

Taxes are the price we pay for a civilized society. Taxation with representation and accountability is what we should demand. Before we cast our votes, we should know the objectives and we must demand specifics and well supported cost/benefit justifications. It is our right, and our elected officials are obligated to provide them.

A Letter from the President

Dear Neighbors:

My mom would wait a few minutes and then I would hear from the kitchen, "Peter please take out the trash." I'd respond, "in a minute mom." Mom would wait a little and then ask again ever so patiently. I would reply with "Yes, mom," hoping that if I said "yes" she would stop asking. But some time would pass and I hadn't taken out the trash yet, so again mom would ask ever so nicely, "Peter please take out the trash." Aggravated, I would jump up, go out to the kitchen, say something under my breath, and take out the trash. Mom would just turn and say, "thank you."

Mom never gave up. Mom never lost her temper. Mom remained calm and polite. Mom just continued on after her goal, to get the trash out. When dealing with the City and our elected officials we need to be just like Mom. The difference is it takes a lot more asking and persistence. In dealing with City and elected officials, even Mom might have lost her temper.

Take SB1818 for example. Citizens throughout the City and the State are saying what a terrible law this is. What do we hear from the other room (our City Council), "It's a state law, our hands are tied." Yet, cities across the state have enacted ordinances in an attempt to mitigate this destructive legislation, but not our City. We hear over and over, "our hands are tied."

So, what can we do?

Be just like Mom. Never give up! Stick to our goal, get the trash out. Laws and legislation are changed all the time. SB1818 is a new law, it was done, and it can be undone. We do not have to accept "our hands are tied."

This really goes for anything we think needs to be done by the city or the state. Keep asking until it's done. This is the reason we added our new section on our website called "Our Position." We've tried to be clear and concise on how the board and membership view an issue so you can use the information to keep asking.

We have also sent out with our membership cards an Action Alert. The Action Alert tells you what you can do to help. Please keep the action alert and call more than once.

Take a lesson from Mom. Persist. Mom knew eventually she would get what she wanted and we can do the same with the City!

Valley Village Park Tree Planting

In 2002 a tiny parasitic insect, with an insatiable appetite for eucalyptus trees, ravaged southern California. In the San Fernando Valley thousands of trees died, including the majority of eucalyptus trees in Valley Village Park. Villagers witnessed the devastating sight of City arborists removing an entire grove of mature trees that had provided beauty, oxygen, and shade around the picnic and play areas. However, Villagers responded quickly to this environmental crisis.

The Valley Village Homeowners Association took action and helped residents form a tree planting committee. Lead by Andrew Sacher, the

small group worked with City arborists,
Department of Recreation and Parks, City
Councilmembers, Department of Water
and Power and Tree People Association to
develop a plan and replace the lost
trees. In October of 2003 a small army of
volunteers, including scouts, school
groups, families, and friends, and city
employees worked all day to plant over



50 young trees. At the end of the day every individual had a great sense of personal accomplishment and lasting contribution to their community.

Five years later those young trees are flourishing and we are planning Phase Two. This time the Valley Village Homeowners Association and Neighborhood Council Valley Village are joining forces to make a greener park for future generations. Andrew Sacher is leading the effort again and is looking for individual and group volunteers. Take part in this enjoyable and satisfying event. Call one of the following phone numbers. On March 14, 2008 Mike Feuer wrote to the CEO of the MTA, "...I contacted you to request that the Metropolitan Transit Authority take timely steps to provide funding to conduct the design study needed for...sound walls planned for the 170 Freeway through Valley Village. ...this community has long been promised this project and throughout their wait has dealt with the negative impact of the lack of sound walls. It is time for the MTA to make locating the funds needed to begin the design study phase of the project a priority and to keep its commitment to Valley Village."

Assemblyman Feuer will speak about legislation that impacts Valley Village and will take questions.
