Neighborhood Councils

First Draft for Citywide System Published

Under the new City Charter, residents of Los Angeles will be able to communicate to the City government their concerns and interests through local Neighborhood Councils.

The concept is to have residents, merchants, schools, workers and other stakeholders in a community work together to promote more public participation in government. The first draft released by the Department of Neighborhood Empowerment (DONE) suggests that the council represent an area of at least 25,000 people. The councils will set their own agendas, define their geographic boundaries, write their own bylaws and propose their own budgets.



How much financial or other support the City will provide is not yet clarified. However, there will be DONE offices throughout the city to provide access to computers and copying machines. There are also plans to make all meeting dates and information available on a WEB site.

Valley Village Homeowners Association can be a core part of a Neighborhood Council. We have functioned very successfully in representing our concerns to City of Los Angeles officials. However, it will be wise to take an active part in the larger outreach of a Neighborhood Council or we may find our community absorbed into some other group.

The Association needs interested volunteers for a standing committee to study the present draft and plan how best to take part in this process. Call the Association phone 818.506.5158.

VVHA Board Elections

It's time again to elect the next Valley Village Homeowners Association Board of Directors. The election will be held at the January 17th General Membership meeting. (See page six for location information) You must attend the meeting and be a paid up member of the association to be eligible to vote. Ballots will be distributed at the meeting and the results will be announced at the end of the meeting.

The By-laws of the Valley Village Homeowners
Association require that the membership elect a new Board of Directors every two years. To run for the board, you must own a home or condo in Valley Village, reside in Valley Village and be a paid-up member of the association. Candidates are qualified and placed on the ballot by the Nominations Committee. The committee selects the candidates from interested nominees and incumbents.

Don't worry, there are no absentee ballots, butterfly ballets or punch cards to deal with.

Rite Aid Liquor Permit Denied

Specific plan restrictions pay off for Valley Village


Associate Zoning Administrator Jon Perica, denied a conditional use permit for the sale of alcoholic beverages at the Rite Air Drug Store at the corner of Magnolia Boulevard and Whitsett Avenue. His findings showed the effectiveness of the Valley Village Specific plan, which the Association worked so hard to create.

Administrator Perica stated the location will not be desirable to the public convenience or welfare. It is not in proper relation to adjacent uses of the community, and will be materially detrimental to the character of the immediate neighborhood.

He also made a strong statement about the failure of the Rite Aid Corporation to properly landscape the property as they had agreed to do, citing the requirements set out in the Valley Village Specific Plan.

The Association is gratified that our vigilance has proved to be effective.

Celebrates Successful Fall Season

Colfax Elementary received news of a special gift just in time for the winter holidays. The school has been named as a recipient of a new kindergarten playground from the Anne and Kirk Douglas Playground Award Fund. The 50-year old equipment outside the kindergarten classrooms will be replaced and the new play area named for Cindy and Douglas Bean. Mrs. Bean, who has taught kindergarten at Colfax for 26 years, won the Los Angeles Times "Teacher of the Year" award in 1996.

Before winter vacation, the students entertained their classmates, teachers and families with presentations by the school orchestra, under the direction of Mary Barton, and the musical, <u>Annie</u>, directed by Kim Seder. This is the first season for instrumental music at the school in many years.



The next major project will be a drive to raise money for expanding and improving the library. Colfax Elementary needs to raise a minimum of \$20,000 in order to qualify for matching funds and assistance from the Wonder of Reading program. Wonder of Reading, a non-profit foundation, helps Los Angeles schools by enlarging and renovating their facilities, providing additional books and training community volunteers to work in the school libraries.



Call businesses who use our neighborhood as a free billboard and tell them you don't appreciate the litter.

For sign removal, especially multiple commercial signs and those placed out of reach, call the Street Services hot line at 213-473-4745. Betty Moon has replaced Ray Carr as the senior inspector in this area. She can be reached at 213-473-4515.

Don't be afraid to pitch in. Take down garage sale signs from poles, and encourage your neighbors to do the same.

Remember, posting signs on public poles, for garage sales, yard sales and any goods or services, is against the law. And when these signs proliferate, they are a real eyesore.
