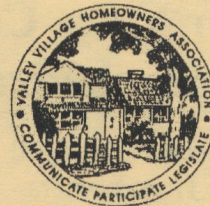

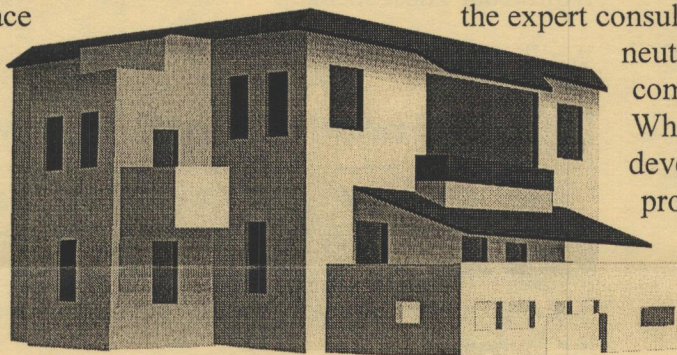

## From The President

**Mansionization:** Hi! Valley Village Homeowners Association anticipates a continued focus on land use issues. I receive phone calls every day about so-called "Mansionization" and all of these calls are begging us to address this situation. The high housing prices and low interest rates have spawned a rash of new developments, be they condos, townhouses, apartment buildings or single family homes. There are projects underway to replace older and smaller family units with much larger and costlier units. We ask, has anyone thought of the infrastructure such as schools, traffic, water, etc.? Not to mention the long term residents who have rented these affordable units for years, what is to become of them? Many are seniors living on a tight budget. We are fully aware of these problems and are addressing our concerns to Councilmember Wendy Greuel.

We are also working on the mansionization problems. We have no intention of trying to stop the building of two story homes. We want to address the increasingly common practice of building a large home on a small lot, where the house seems to take up every inch of open space. There must be a viable



solution and we will find it. To that end, we have hired an architect-design consultant who will work with us on a committee of representatives from VVHA, Neighborhood Council Valley Village (NCVV) and other members of the community. We have met twice with Councilmember Greuel's staff, but feel we need a neutral expert who can steer us in the right direction to come up with a viable plan and solution. I am sometimes asked, "What do our membership dues do?" Part of your dues will pay for the expert consultant. His vast experience and his neutrality is exactly what we need to come up with a successful plan. When this committee has developed some constructive proposals to mitigate this complex problem, we will call for a Town Hall meeting and present it for the residents consideration.

**Public Storage Facility:** Tom Paterson and I attended a Planning and Land Use Management (PLUM) meeting downtown to finalize the plans for the self storage building on Laurel Canyon Boulevard adjacent to the entrance to the 101 freeway. Several kinks had to be worked out to assure that the project would conform to VV Specific Plan requirements. There will be a hearing before the City Council for final approval of the project. I am optimistic that the

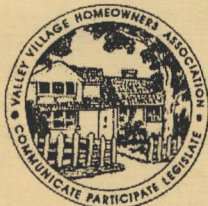
