Rob's Beat

Happy New Year, Valley Village! I hope that everyone had a fantastic Holiday season.

Although 2022 presented us with some challenges, Valley Village finished the year lower in crime than 2021 and remains one of the safest places to live in the City. Valley Village finished the year with a 6% total crime reduction. Property crime was down a combined total of 7.5% with car thefts and break-ins down significantly. The only increase in Property Crime was in personal theft, up by 15 crimes total for the year. Robberies were also down almost 40%. The only increase in violent crime was in Aggravated Assaults, which were predominantly transient related. The LAPD will continue to prioritize transientrelated crime and quality of life issues. Although the transient population in Valley Village is among the lowest in North Hollywood Division, I remain optimistic that new strategies and allocated resources will continue to have a positive impact on those still living on our sidewalks and streets.

The holidays, as always, led to an increase of mail and package thefts. I remind everyone to really try your best to not leave packages on your porches. Have a friend or neighbor pick them up for you or require a signature or pick up from a UPS, FedEx or Amazon location. Also, I would encourage people to consider paperless options for bills and banking. There really is no longer a need for that mail to be sitting at your door anymore.

Welcome 2023 and I will see you all soon. Stay Safe and be well.

The Board's last meeting of 2022 was held on November 7th via Zoom, Seven Board members were present for a quorum. Committee reports focused on beautification of the north side of the on and off ramps to the 101 freeway at Laurel Canyon. ~We discussed the transition of a new editor and publisher for our newsletter, The *Valley Villager.* ~Considered the space and décor difficulties experienced at the last Membership meeting and decided to look for another venue. ~Reviewed actions taken by other organizations to coordinate efforts that will stop the State legislature from eliminating local control on housing. ~Examined an inventory of Association archives to determine the value of their contents going forward. ~Heard an update on the status of building and demolition permits. For your information, membership outreach includes room rental and donations while the administrative category includes stationery, the P.O. Box and other miscellaneous expenses. Utilities includes our website and phone line. This year the cost of the July 4th Parade went over budget due to inflation; an adjustment will be made in next year's budget.

Jim Herrick Swim School CUP Renewal

The Jim Herrick Swim School is undergoing a Plan Approval application for a previously granted Conditional Use Permit (CUP) to continue business as a swim school in Valley Village. VVRA sent a letter of support in November to Dylan Herrick. The VVRA board voted to support permanent extension of the CUP, located at 11846 Kling Street in Valley Village, so long as there are not changes to the operational model of the school.

Jill Stewart, our January Speaker

Jill Stewart is a seasoned Southern California journalist who first made her mark as a reporter focusing on urban affairs, education and the environment for the Los Angeles Times, Buzz, and New Times Los Angeles. She also served as executive director of the Coalition to Preserve LA and oversaw the campaign for Measure S which would have reshaped the City's process for approving higher-density housing projects had it not been defeated in 2017. Jill has been a board member of the LA Press Club for 14 years and



has won many awards for her journalistic work. She has also worked with nonprofit groups to help them navigate the state political system. She is now City Editor of the Los Angeles Daily News. At this meeting, she will give us a peek into the City governance approaches we might see from key players in the State legislature and on the City Council and what we might expect from the upcoming trials of Jose Huizar and Michael Ridley-Thomas.

Review-Assess-Act-Repeat

It's January, a year has passed, and it's sometimes fun, sometimes frustrating to see where VVRA landed as we roll out another year. So, here's an update of what *The Valley Villager* was reporting just a year ago.

We were all a-buzz with redistricting and trying to figure out our new legislators and who we could now turn to in light of the new lines on the local map. It turns out that Valley Village is still in the 2nd District, with Paul Krekorian as our City councilmember – in fact he is now President of the City Council. As far as the County goes, VV is now in District 5, represented by Kathryn Barger, who came to introduce herself at the Association's meeting in October.

In January, we were also talking about the new application fees raised by the City Planning Department, which offered reduced fees to help day care centers, farmers markets and other entities that serve their local communities.

Then we talked about the growing volume of work to make sure those in need have enough to eat and those who are helping to make that happen, particularly the North Hollywood Interfaith Food Pantry. NHIFP distributes bags of food Monday and Friday mornings out of 1st Christian Church on the corner of Colfax Avenue and Moorpark Street. Drop-offs of food are always welcomed during their scheduled distribution times. Check their website for operating times: nhifp.org.

We also explained the latest moves with the FAA in the ongoing effort to make sure all areas share the noise of planes leaving Burbank Airport. A petition by Mike Feuer, then City Attorney, to move the flight path from south to north of the 101 freeway was rejected by the 9th Circuit in October 2021. No further developments have been recorded. The flight paths stay as is for now.

Lastly, and perhaps most important, we traced the work of Our Neighborhood Voices, a local organization working on an initiative to put on the 2024 ballot that would restore to local entities the ability to plan the locations of much-needed "affordable" housing and reduce the power given to developers by the politicians in Sacramento who passed SB9 and SB10 at the end of 2021, giving them almost unlimited permission to build anything but affordable housing.

As the Board reconvenes, with continuing and new members, *The Valley Villager* will report the Association's plans for this year – both on these projects and on the inevitable new issues that crop up. Stay tuned. We're glad to have you along.

State Housing Bills

In recent years the State Legislature has passed a number of bills to encourage housing production, including the wellknown SB9 that permits the subdivision of single-family homezoned lots into two smaller lots with up to two homes allowed on each. However, there are many other bills proposed that would make small, incremental changes to the rules for housing production in California. Here are two of the most significant:

AB 682 (Bloom) Adds "Shared Housing" as a category in density bonus law and defines a "Shared Housing Building" as a residential or mixed-use structure with 5 or more Shared Housing units, with common kitchens and dining areas and a residency of more than 20 days. They may be 100% shared housing units or up to 25% of floor area designated as regular dwelling units plus ground floor commercial. Also added is a "Shared Housing Unit" with one or more habitable rooms that include a bathroom, sink, refrigerator and microwave oven, which meet the minimum room area and guest room requirements in the California Residential Code. If a project is providing at least 10% low-income units or 5% very-lowincome units or is a senior citizen housing development there is no minimum unit size and no minimum bedroom requirement.

AB 1551 (Santiago) extends AB 1934to 2028. The reenacted law allows incentives for commercial development if the developer enters into an agreement to provide affordable housing onsite or the project is located within a half mile of a major transit stop and is in close proximity to public amenities such as schools and employment centers and at least 30% of the dwelling units are for persons with low incomes or 15% of the units are for those with very low incomes.

Dorothy Apple:

I grew up in Toluca Lake and attended our local public schools. I am a resident of Valley Village since 1998 and work in the community. I have been a board member of the Valley Village Residents Association since 2012 and the VVRA July 4th Parade chair for the last nine years. I have served on the NCVV board since 2007 and was secretary for eight years and currently hold the treasurer position. I am an active member on the Planning & Land Use committee. I am involved in the Valley Village Neighborhood Watch Program and Community Emergency Response Team, and work closely with our local LAPD and LAFD officials. I believe smart development, safer streets, good schools and sound infrastructure are key to keeping the integrity of our community intact. I believe that developers should abide by the Valley Village Specific Plan (now being updated as the Community Plan) and rarely an exception should be made. I look forward to being an advocate for residents and stakeholders in Valley Village, to ensure that our neighborhood remains one of the most desirable in the city of Los Angeles.

Beth Fulton:

My name is Beth Fulton. It has been my privilege to be the President of VVRA for the past four years. I have lived in Valley Village for 18 years. I am married to my husband Dave and have two children, Nick and Mckenna. My son has graduated college and now resides in Los Feliz. My daughter, Mckenna, is currently a sophomore at Providence High School. Both of my children attended Colfax Elementary. I have experience working on the Neighborhood Council (NCVV) in the capacity of Planning and Land Use Chairperson, I hope to use that knowledge to continue to assist VVRA in maintaining their watchdog work on all development projects within Valley Village. There are many reasons that I cherish this neighborhood – the sense of community, the beautiful trees, the July 4th Parade and the overall quality of life. We are not without our challenges; the rising homeless population, the potential changes to the Community Plan, overdevelopment as a result of California Senate Bills 9 & 10, the significant loss of mature trees and a rise in crime amid a diminished police force. I have long admired the historical work of VVRA. For nearly four decades the Association has worked tirelessly to improve the standard of living in Valley Village. I look forward to continuing that work with the challenges ahead. Thank you to all of those who support VVRA through membership – your support allows us to continue the vital advocacy that is needed to protect our neighborhood.

Paul Hatfield:

I have served Valley Village for 16 years, 10 on the Neighborhood Council and almost 6 with VVRA, including 4 years as president. In recent years, I have successfully led the effort to eliminate what was a growing homeless problem in the park. This included eliminating cover on the chain link fence adjacent to the 170 and getting CalTrans to securely shut access to the pedestrian tunnels with steel doors. I also took the lead with Beth Fulton to oppose Studio City's proposal to have Burbank Airport departures routed exclusively north of the 101, which would greatly increase the noise and range of jet engine noise over Valley Village. As it stands, Studio City's attempt has been stalled in the courts; it will be ultimately up to the FAA to decide. The agency has heard our arguments. I established communication with our new County Supervisor. Katherine Barger. VVRA has developed an excellent relationship with her. I look forward to continuing my efforts in support of our community in the public arena.

Tina Hookom:

I have lived in Valley Village for the past 17 years with my husband David and our two children, Madeline (15) and Juliette (12). Our family has benefited from living in a neighborhood that feels and acts like a community. As a family, we have tried to support the efforts and hard work of the Valley Village Residents Association. We have volunteered to beautify our streets with painting poles and murals, donated time, and resources for the food drives, and participated and engaged in helping with the July 4th Parade. Also, a co-leader of a neighborhood Girl Scout troop. It is a core value of mine to model and demonstrate to our children the importance of volunteering and raising your hand to help. If I were to be elected, I am excited to engage in beautification projects and create community organizing events to bring more kids and families into the fold of enriching our community

Sandy Hubbard:

I have been a homeowner/resident in Valley Village since 2000. During that time I have served on the VVRA board, as well as the Neighborhood Council Valley Village. With the growth of the North Hollywood/Valley Village communities and both existing and new transportation corridors that surround Valley Village, I am interested in ensuring the fundamental cohesiveness of the NoHo Community Plan and Valley Village Specific Plan's abilities to retain and safeguard our unique community characteristics (which include both single-family and multi-family housing solutions), and look forward to serving with the other board members to achieve that goal.
