Burbank Airport Plans Halted

Terminal Development On Indefinite Hold

According to an article by Jason Kandel in the September 28th Daily News, Burbank Airport's governing board voted on Thursday, September 27th to put on hold indefinitely all terminal development plans in the wake of the events of September 11th. According to Burbank Airport spokesman Victor Gill, "...the situation is so unclear that it really precluded any sensible steps forward in the terminal discussion." Configuration of a proposed 14-gate terminal could change substantially with the new security measures following the attacks.

Burbank Mayor Bob Kramer called it "an appropriate response to the continuous repercussions of the terrorist attack." But he also cautioned "that the present circumstances should not spell a suspension of the collective efforts by our partner cites, the authority and Burbank to reach a consensus on a future terminal plan."

The Authority's Thursday vote will not affect Burbank's October 9th mail-in election, when voters will weigh in on Measure A, which requires that any terminal plan include a mandatory nighttime curfew and a cap on operations at the airport. The terminal has been the focus of debate over noise and traffic issues for years.

"There are just too many questions without answers for us to make good judgments on a significant project like the terminal," Airport Authority President Chris Holden said.

Neighborhood Council Progress

The formation of The Neighborhood Council of Valley Village continues to make progress. In September, a Steering Committee was organized and met to plan outreach activities.

The first public meeting was held on September 12th in Caldwell Hall at the First Presbyterian Church on Colfax Avenue. More than 35 people were in attendance. The meeting was announced by a mailing to all current and past members of the Association. Also notices were hand delivered to Valley Village businesses, schools and religious institutions. Over 1400 flyers were distributed to "stakeholders." (Continued page 2)

The next step is to continue to spread the word about our Neighborhood Council of Valley Village (outreach), seek agreement on the by-laws and then file an application for certification with the Department of Neighborhood Empowerment.

Important Meetings

In the first month of his tenure as the new mayor of Los Angeles, James Hahn invited Valley community leaders from the educational, business and residents associations to a working breakfast meeting. This was a select group, and Valley Village Homeowners Association was pleased to be included. Mayor Hahn and his deputies from various city departments asked what the Valley residents want from City government. Implementation of the new City Charter Neighborhood Councils was a major interest of most of those attending. The Mayor pledged to stay in close touch with Valley communities.

Congressman Howard Berman responded to Valley Village concerns about the changes in the State Senate 21st district by promising to arrange a meeting with State Senator Jack Scott in the near future. This will be an opportunity to express our determination to limit the amount of noise pollution generated by Burbank Airport. Since the eastern boundary of the 21st district has been moved all the way to San Gabriel Valley, it is urgent that Senator Scott be made aware that communities west of Burbank Airport are an important part of his constituency.

Billboards, Is Less More?

In June the City Council of Los Angeles approved the initiation of an ordinance to permit the relocation of billboards from the surface streets to industrial zoned lands bordering the freeways. Up to 70 V shaped, double faced monopole billboards with 670 sq.ft. per sign face would be permitted to face the freeways in exchange for the removal of approximately 2,000 billboards from the surface streets. The ordinance would also ban new billboards along surface streets, a goal homeowner associations have been trying to attain for over 20 years.

The relocation ordinance, being pushed by the billboard companies and Councilman Mark Ridley-Thomas, would for the first time open up the freeways to billboards, breaching a ban that has been in place for 50 years since construction of the freeway system got underway. The ban has kept the freeways within Los Angeles essentially free of billboards, unlike other cities where they clutter and deface the landscape. The proposed relocation ordinance, while superficially appealing, is a Faustian bargain that would not really solve the problem of billboard ugliness in the city. Rather, it would merely shift a portion of it onto the freeways. With an estimated 10,000 billboards along surface streets, even the removal of 2,000 billboards would leave the streets looking just about as cluttered as they are now. Billboard companies will be removing mostly their smaller signs that generate less revenue while leaving in place most of the large, 670 sq.ft. monopole billboards which have the greatest adverse visual impact.

The Association has testified and sent letters in opposition to this ill-conceived ordinance that favors the billboard companies over the public good. The next step in the approval process is for the City Attorney to determine whether an environmental impact report is required for the ordinance. After that the Planning Department will conduct public hearings and prepare a staff report and recommendation to the Planning Commission.


State and Congressional Redistricting

Recently the State Legislature approved, and the Governor signed, legislation that alters the boundaries of the State Assembly, State Senate and Congressional districts so that they reflect population changes reported by the year 2000 census. The result of that procedure is some good and not so good news for Valley Village.

The good news is that Valley Village and the south Valley is located in the 42nd Assembly district represented by Paul Koretz that straddles the Santa Monica Mountains and includes mostly stable communities. This is consistent with the legal requirement that districts be compact, contiguous and represent "communities of interest".

The bad news is that the south Valley communities of Valley Village, Studio City, Sherman Oaks, Encino and Tarzana have been shifted into the 21st State Senate district, represented by Jack Scott, which extends 20 miles to the east and includes the cities of Burbank, Glendale, Pasadena Arcadia and Temple City. This large district that brings together portions of the San Fernando and San Gabriel Valleys is territorially incoherent and lacks "communities of interest". A clear example of this is the Burbank airport noise issue. The communities in the San Fernando Valley are opposed to uncontrolled expansion of the airport terminal

which would lead to greatly increased noise pollution. The communities east of the airport favor expansion because they would realize the economic benefits without being impacted by the noise. It will be difficult for Jack Scott to represent both parts of his expanded district. Rather than to have logical boundaries of communities with similar needs.



The new Congressional district boundaries have also ignited a dispute between Congressmen Brad Sherman and Howard Berman The new boundaries shift a substantial number of Anglo residents in the west San Fernando Valley out of Sherman's district into Berman's and replace them with Latino residents of the northeast Valley. The purpose of this change is to protect Congressman Berman, whose district is becoming increasingly Latino, from a primary challenge by a Latino opponent. Brad Sherman strongly protested this shift and the proposed boundaries were

adjusted slightly to leave more Anglo voters in Sherman's district. However, the new district will likely be challenged in court by civil rights organizations because they divide the Latino vote in half between the two districts, making it more difficult to elect a representative of the Latino community to Congress.

Valley Village remains in Howard Berman's district.

City Redistricting

On City Council redistricting, Mayor Hahn and the City Council have appointed a 20 member citizen commission to recommend a redistricting plan to the City Council. It is hoped that a new district may be formed that will be entirely in the San Fernando Valley.

LAVC Committee

Lori Dinkin, president of V.V.H.A. has been invited to serve as a member of Los Angeles Valley College Citizens' Committee.

The first meeting will be an overview of the current proposed projects for the college under the bond sale revenues.

Lori was recommended by Tyree Wieder, Ed.D. president of L.A.V.C. to be one of 15 members on the committee.
