#### No PLACE AT THE TABLE - YET

Burbank Airport, the FAA and Us

In November 1999, Federal Aviation Administrator, Jane Garvey wrote a letter to the LA Times clearly urging the City of Burbank and the Airport Authority to involve all the affected parties in the airport discussions. Not only was the correspondence not made public until it was finally run on January 2, 2000, but the Los Angeles residents have yet to be invited to the negotiations.

On January 17, 2000, representatives of VVHA and several other community groups again met to discuss how to make our voices heard by the people who will decide the airport's impact on our communities. Since the City of Burbank is the primary decision-maker the group decided to embark on an "education campaign" aimed at the Burbank voters.

Public relations pieces about the airport, which have been distributed by the City of Burbank, will be challenged and rebutted through our own flyers and handouts. Furthermore, this group has pledged to contact our representatives at every level, urging them to find a way to get us "a place at the table." Our position is as follows:


- 1) The new terminal should be a true replacement terminal, one which does not exceed the present capacity, while being compliant with the law. Expansion cannot take place until specific growth controls have been adopted and the environmental impact of that growth assessed.
- 2) There should be a 10:00pm to 7:00am mandatory curfew.

- 3) The Eastern runway should be opened and some departures routed over Glendale and Pasadena. This would be a true "share the noise" arrangement.
- 4) Adopt a permanent cap on flights and noise "budget" based on the State noise limits.

The Studio City Residents
Association has printed

that, despite her admonitions, we have yet to be
included in the Airport talks.
Valley Village Homeowners
joins them in this effort.

It is important that you sign and send the enclosed card as soon as you receive this mailing, as the Burbank City Council will very likely vote on the airport settlement in April.

#### **LETTER TO THE LA TIMES**

From Jane Garvey, Administrator of Federal Aviation Administration

The issues surrounding the Burbank-Glendale-Pasadena Airport dispute are difficult local concerns, with national implications.

An editorial on the Federal Aviation Administration's role in discussions on those issues was insightful ("FAA Chief's Input Needed," Nov.7, 1999). The editorial suggests it is time for FAA to provide more guidance to the parties on elements of the framework for settlement agreement. I agree.

The real challenge is to provide that delicate balance between local needs and national interests. The key to any resolution is ensuring that all relevant parties are at the table and that each has a stake in a positive outcome. These parties are the cities, the airport authority, area residents, the airlines and the FAA. Unfortunately, not all the players were involved when the framework for settlement was produced.

FAA has discussed the framework with the city and the airport authority because we believe several elements of the agreement violate federal law.

FAA has discussed the framework with the city and the airport authority because we believe several elements of the agreement violate federal law. We continue to advise them as to how the agreement—or any subsequent redevelopment plan—can conform to applicable federal law.

Resolution of these issues must be reached locally and must comply with federal law. The FAA will continue to strongly encourage all the interested parties to involve themselves in the process.

Everyone with a significant interest in the outcome must be at the table. Issues that affect parties who were not included in the discussion--such as the proposed ban on eastbound takeoffs--should be removed voluntarily from the framework. Until this happens, the agreement between the city of Burbank and the airport authority remains a first, although essential step in achieving the delicate balance that will provide the most modern, safe terminal for the airport and address the concerns of the local communities.

City of Burbank Suspends Work on Deal for Airport
In a Feb. 3 letter to Carl Meseck, president of the Burbank-Glendale-Pasadena Airport Authority, Mayor Stacey Murphy, said that the city would suspend work on a development agreement for a new terminal at Burbank Airport.

Mayor Murphy said federal officials must help iron out legal

issues before negotiations can



resume. The Burbank City Council has already passed a measure calling for an advisory vote on the draft agreement, however, no date for the vote has been set. Some residents have been collecting signatures for a hard-line city ballot initiative requiring a mandatory curfew and limiting the size of the new terminal.

# THE GOOD, THE BAD, AND THE UGLY

Gelson's Market has turned their parking lot into an urban park. Planters filled with roses, are a treat to see as one heads for the store. They are well maintained and enhance the area. VVHA congratulates the management for being responsible community merchants.

After numerous meetings and endless letters from VVHA, the decaying building on Magnolia Boulevard and Whitsett Avenue is finally being razed. Our best hope is that while the owners search for a tenant the property will be fenced and some landscaping installed. We will need to be vigilant about what type of business goes into the space and to be sure whatever is built conforms to the Valley Village Specific Plan.

Colfax Elementary School has completed replacement and replanting of the fenced areas of the schoolyard. The City responded to neighbors concerns and the result is quite satisfactory.


Negotiations continue with both Rite Aid Drug Store and the 7-11 Convenience Store to improve the appearance of their properties. Reassurances from the companies are numerous but no action is forthcoming. VVHA will continue the effort; members who patronize these businesses might help by expressing their displeasure to the store managers.

#### **PROJECT RAPID BUS**


Metropolitan Transportation Authority has been holding meetings to introduce the public to the plans for a so-called Rapid Bus on Ventura Boulevard to run from Woodland Hills to Studio City in the Valley and then downtown. It will be a special commuters' bus with stops a mile apart and technology on board which will turn traffic signals to green as it approaches.

The MTA representative had slides and charts to show what a great time-saver this would be. However, answers to questions from citizens attending tell a rather different story. For instance, there will be no parking facilities along the route for users who live too far from Ventura Boulevard to walk to the bus stop, Ventura Boulevard merchants who suffer from inadequate parking already and residents near the boulevard who suffer from commercial parking on their streets were all skeptical of the plan.

# **FREEWAY NOISE**






# Positive Development
