From The President

I am leaving with a good feeling as I have done the very best that I could for our community. Valley Village is a great place to live. Our Specific Plan must take credit for this! And we aim to keep it that way.

I am taking this opportunity to thank our members for their support and interest in our Village. I have had the privilege to work with several dedicated Boards of Directors; some have been on the Board for years. "No man (or woman!) is an island". Without the hard work of many Board members nothing could have been accomplished.

As Hillary Clinton says, "it takes a village..." And yes, that can apply to our lovely Valley Village. We have had terrific, positive response to our survey on the Mansionization Plan. We thank you for the many surveys that you returned as well as the calls and emails to Councilmembers Jack Weiss and Wendy Greuel. Of approximately 300 mail-in responses only 5 were negative.

These results, as well as our proposed plan, have been forwarded to our Councilmembers and to Dan Scott of the City Planning Department. I hand-carried the plan to Mr. Scott and discussed it with him at length. His feedback was very positive. We have

requested that the Mansionization Plan be added as part of the Specific Plan. Also we are asking for an updated addendum to the plan. This is needed because former city planner Bob Sutton (who has now retired, hurrah) had kept our previous addition in his office for seven years without taking action.

I recently had a telephone call from the Tarzana Homeowners Association regarding Mansionization. I recommended our consultant, Mike Melcalf, to them. I heard from Mike that they were in touch with him. We are so glad that other communities share our concerns and we hope that our politicos will finally see the light and really act on the constituents concerns.

That brings me to our membership meeting on Thursday, February 22. Gangs are a very serious, very troubling presence in the Valley. They are making their territory move closer to the southern part of the Valley. What can we do? We hope to get some answers at the upcoming meeting. We will have important speakers from the Police Department and the City Attorney's office to inform us. It is important that we show them by the number of citizens attending that we are concerned, even alarmed.

To all our members once again...thank you; thank you!

BYLAW CHANGE NOTICE TO ALL MEMBERS

ARTICLE V, DIRECTORS

5.02 Number and Qualifications. The Association shall have no less than four (4) and no more than six (6) Directors, who collectively shall be known as the Board of Directors. The Directors shall be residents of the State of California and must own and reside in single family dwellings or condominiums within the geographic area defined in Section 1.05, and must be members of the Association in good standing.

What part of the crime picture in Valley Village does gang activity represent? How can we be vigilant in containing it? **Lt. Gregory Baltad** Head of the Gang Impact Team for Los Angeles Police Department at North Hollywood Station will inform us of what is currently being done and what the plans are for the coming year.

Deputy City Attorney Brian Sottile and Deputy City Attorney Jonathan Galatzan will be featured speakers. Mr. Sottile has been with the City Attorney's office for 8 years. He is now assigned as Neighborhood Prosecutor at the North Hollywood Station addressing criminal activities pro-actively before they are able to grow into serious offenses and larger problems that lead to urban decay. Prior to joining the LA City Attorney's office, Mr. Galatzan worked on complex civil defense cases. He is now assigned to Citywide Nuisance Abatement Program (CNAP) and works on targeting structures, abandoned properties that create blight plaguing neighborhoods.
