#### Councilman John Ferraro

The Association was very saddened to hear about the passing of Councilman John Ferraro. Mr. Ferraro's district included the eastern end of Valley Village and he will be remembered for his many efforts in support of Valley Village.

#### Graffiti: We're Still Fighting

Nobody likes graffiti, and the Association is working to reduce this neighborhood blight. Our volunteer graffiti buster, Frank Bender, is painting out graffiti in Valley Village on a regular basis. Meanwhile. the Association recently wrote to Mayor Richard Riordan, L.A.P.D. Chief Bernard Parks, County Supervisor Zev Yaroslavsky, and Chief Probation Officer Richard Shumsky of the L.A. County Probation Department to ask for greater city and county support of anti-graffiti efforts.

In response to our letter, Chief Probation Officer Shumsky promised that all probation cases involving graffiti vandals will now be assigned to a single probation officer rather than spread among many officers. The responsibility for supervising persons convicted of graffiti crimes will now lie with Probation Officer Michael Cooper, whom we may contact when needed.

Captain Ann E. Young of the Van Nuys Division of L.A.P.D. responded to our letter to Chief Parks regarding the Community Tagger Task Force. We asked that the Task Force, which operates with only two officers from its Van Nuys base, be expanded across the Valley. This idea has been considered, Captain Young said, but "resources are not available to expand the current allotment of personnel." It is hoped, she added, that the reinstatement of our Senior Lead Officers will assist in the battle against graffiti.

We also asked that all juveniles arrested on suspicion of graffiti vandalism be booked into Juvenile Hall rather than simply given a citation. Suspects booked into Juvenile Hall must appear before a judge or court commissioner, who may then assign probation terms, sentence the convicted minor to Juvenile Hall or, if the dollar amount of damage warrants, to the California Youth Authority.

Captain Young acknowledged that "currently, juveniles detained for graffiti are either issued a citation or arrested." However, she pointed out, the dollar value for felony graffiti has decreased from \$5,000 in damage to \$400. "This enables officers to arrest a far greater amount of graffiti violators," she said, "and the City Attorney has demonstrated a commitment to prosecute any tagger who creates more than \$400 in damage."

#### **Crime Prevention**

The Number One Crime in Valley Village

During the annual Basic Car meeting, our Senior Lead Officer Ed Brentlinger reported on some of the most prevalent crimes in the Valley Village area. The leading crime by far is BFMV (Burglary From Motor Vehicles).

This is one of the most preventable crimes, yet the rate has been soaring. Always lock your car. Never leave valuables in your car. If possible, park in your driveway or a lighted area.

Officer Brentlinger reminds us that we are the eyes and ears of the Police and to be aware of suspicious persons loitering in the area. Keep watch while your neighbors are at work. Install motion detector lights.

#### We're On The Web

Thanks to Valley Village resident Gregory Gooden and his company Annex, Valley Village and the Valley Village Homeowners Association now have a place on the web. See www.valleyvillage.net. Gregory started the site to try to foster a sense of community in Valley Village and to show how his software, Ecobuilder, could be used. The Valley Village Story and membership information has been added to the site. In the future, we hope to add Valley Villager archives and other Association information.

#### **Chandler Median**

In response to a letter sent by the Association to Supervisor Zev Yaroslavsky, the MTA completed tree planting on the Chandler Boulevard median east of Colfax Avenue. In the near future, trees will be planted in the remaining gaps where the billboards used to be at Laurel Canyon and at Whitestt Avenue. The tree planting, started in 1998, is a significant step in the beautification of our community.

The Metropolitan Transportation Authority is proposing to remove the railroad tracks and put in some additional landscaping as part of the construction of a busway on the Chandler median. There is some strong opposition from citizens who advocate moving the route north to Oxnard Street. However, if the busway is relocated, the MTA's landscaping plan will probably be withdrawn.

The Association is awaiting release of the Environmental Impact Report for the project.

#### Congratulations

Gail Polevoi, Executive Board member has been presented with a Citation by the Board of Public Works of the City of Los Angeles commending her for her numerous tree plantings and trash and graffiti removal undertakings in our community. Congratulations Gail, we are very proud of you!

#### **Busway Hearing**

Another long running controversy is heading for decision this summer. The Metropolitan Transportation Authority (MTA) will vote by mid summer on a proposed busway through Valley Village to link the subway in North Hollywood with Warner Center.

The MTA has scheduled a hearing to take public comments on the adequacy of the environmental impact report for the proposed 14 mile busway across the Valley. The section through Valley Village would be on Chandler Boulevard from Lankershim Boulevard to Ethel Avenue. Copies of the report are available at North Hollywood Library, 5211 Tujunga Avenue, North Hollywood.

A meeting is being arranged between President Lori Dinkin and other board members and County Supervisor Zev Yaroslavsky to discuss the Association's concerns about the location and design of the busway.

#### Valley Village Neighborhood Council

The first meeting of the Valley Village Neighborhood Council steering committee was held on February 21, 2001. Members attending were Lori Dinkin, Tom Paterson, Breice Reiner, Jerry Fagin, Stuart Simen, Peter Sanchez and June Perelson.

Ben Fiss from City Councilman Michael Feuer's staff gave a history of the neighborhood council concept in Los Angeles. Since the adoption of the new City Charter some communities have started the process to become Certified Neighborhood Councils. In December 2000 the City Department of Neighborhood Empowerment (DONE) published a recommended Plan for a Citywide System of Neighborhood Councils. This Plan is based on a vision that Neighborhood Councils are self-governed, self-directed and independent. It is not a final draft and the Plan can be adapted and revised to meet the community concerns. Some of the requirements for Certification are adequate representation among people in the area including residents, business operators, employees, schools and religious organizations.

The Valley Village Homeowners Association will be taking steps to identify the parameters and stakeholders of a proposed council in our area. It is necessary to take a leadership position now or face the possibility of being swallowed up by some other organization that might become the voice of our community. The steering committee for Valley Village Certification will welcome anyone interested in taking part in this new experience in City government. #### **Related News:**

Councilwoman Laura Chick and Councilman Mike Feuer, a City Attorney and DONE Manager Rosalind Stewart conducted a workshop on forming a Neighborhood Council, on February 26<sup>th</sup>.

Attending were active members of various community groups from the Westside and the Valley. The majority of participants appeared to represent homeowners and residents. The panel answered questions and listened to the statements from the floor. There is a strong feeling that the City must budget some funds for outreach or communities will have no way to fulfill the requirements for Certification. The next City budget should include funds for computers, some staff for local offices and mailing costs. Already available for advisory assistance are six DONE regional representatives throughout the City including one in the San Fernando Valley.

#### Is Burbank Airport Expansion About to Fly?

The twenty-two year impasse on expansion of the airport may be reaching an end as the consequences of recent political developments in Burbank. But will it be happy ending for us? A new Burbank city council took office May 1 with a new member of the 5-member council. The new member is thought to be "moderate" on the issue of airport expansion. Two community activists of the three Burbank commissioners were replaced by a former city councilperson and former police chief. The commissioner not replaced has become a point man for expansion. We now expect new movement on a terminal expansion plan.

Burbank voters recently passed an ordinance that requires a city vote on airport expansion. Observers believe that the ordinance will probably fail on legal challenge.

Meanwhile, the airport released a forecast of aviation activity into the year 2015 which projects a substantial scaling back of aviation growth (about 2% a year). This is in direct contradiction to the major passenger and aircraft activity growth projected in the five different terminal expansion plans trashed by the community over the past twenty-two years. This airport study claims congestion at LAX will not have a spillover effect at Burbank because future LAX spillover will be handled by Ontario, Palmdale and Orange County. The downside of this scenario is that future growth is predicted to be after 7 p.m., and from corporate jet activity. An additional concern, confirmed in this projection, is that noise restrictions at Van Nuys Airport will shift nosier jets to Burbank.

A response is being drafted to the findings of this growth projection. The good news is these latest projections essentially support our call for a replacement terminal with no larger aircraft handling capacity than currently exists.

#### Billboards

Lori Dinkin attended a twice postponed hearing at City Hall regarding allowing 140 new billboards to be placed along freeways in exchange for removal of 2100 signs on city streets. According to Councilwoman Cindy Miscikowski there are at least 4000 illegal signs on the city streets. Lori Dinkin pointed out (and was quoted in the Los Angeles Times) that a traffic safety study must be ordered. Billboards will surely distract motorists. After much debate, the council postponed a vote on this issue. The tradeoff does not warrant more clutter, especially along the freeways.

# Dog Use at Valley Village Park



Valley Village Park is a frequent stop for many residents of the area. It's a place for children to play, to picnic or to walk your dog. Recently, taking your dog to Valley Village Park has become a hassle. While reasonable enforcement of leash laws is necessary, Parks and Recreation and Park Rangers have increased patrols to enforce the leash law. One long time resident described the enforcement as harassment.

Park Rangers have been arriving at Valley Village Park in two or three vehicles, driving up on the grass and sometimes calling in police.

Due to the number of complaints received from Valley Village residents, Association President Lori Dinkin called the late Councilman John Ferraro's office to voice the Association's concern about the over zealous enforcement.

- **D.** Commercial and Business Activity: Act as liaison between local businesses and residents. Encourage merchants to keep commercial sites attractive and inform members of the variety of services and retailers in the community.
- E. Programs for Membership meetings: Schedule four meetings a year. Plan and contact possible speakers.



- F. Villager: Submit articles or interviews of local interest for The Villager.
- G. Graffiti control: Promote cleanup of graffiti and litter.



- **H.** Community events: Plan 3 community events encouraging residents to become acquainted with each other.
- I. Sound wall: Communicate with Caltrans and other officials in an effort to facilitate building sound walls on the 170 Freeway.




J. Tree planting at Valley Village Park. See the article Our Trees Are Dying on Page 1.
