
#### Annual Valley Village July 4th Parade

#### **From The President**

Dear Neighbor:

A very ugly situation has arisen in our wonderful Valley Village. There are people at work who are determined to destroy our Valley Village Specific Plan which has protected us from runaway construction and building heights since its inception in 1993.

Let me explain in plain everyday language just what is happening without going into the complicated zoning restrictions. You can hear about that at the Neighborhood Council Valley Village Planning and Land Use Committee meeting on June 8<sup>th</sup> at 7:00pm at Colfax Elementary School.

To our dismay, Stevens' Nursery, including the land it stands on, has been sold. Schaffel Development Company, Gary Schaffel, President, is purchasing the property. We had dealings with Gary Schaffel many months ago regarding a large condo project on Whitsett and Otsego and had come to a satisfactory agreement. This property is now under construction.

Along comes Mark Gelfat who wants to operate the Stevens' Nursery. So far, so good! But here's the kicker: Mr. Gelfat will change Stevens' Nursery, it will be only one third of the current nursery. Mr. Schaffel, the developer, has agreed to this arrangement only if he can construct a four story condominium on the remaining two-thirds of the property. This would require an exception to the Valley Village Specific Plan. The Specific Plan does not allow four stories. Mr. Schaffel has said that in order to accommodate the smaller nursery and still build enough units to make the project viable, he needs to go to a four story building.

When Gary Schaffel purchased the Stevens' property, he was fully aware of our Specific Plan and its height restrictions. In addition, Jim Stevens, the current owner, made no conditions in the sale regarding retaining the nursery.


Please be aware of this dangerous precedent. Our strength has been in the conditions of the Specific Plan. I am certain you are aware of the many monstrous apartment buildings that are four stories or higher in our community. These "stucco mountains" had been constructed before our Specific Plan became a reality in 1993. All new construction since then has to be three stories (or less) in height. This gives our community a cohesive, livable look.

This is not about the nursery, trust me. Yes, a nursery is a welcome business, but in no way can we or will we compromise our Specific Plan (height or other restrictions). There are many developers chomping at the bit to develop projects in Valley Village, we therefore cannot make an exception – every developer will then feel justified to demand exceptions to the Specific Plan. Unfortunately, the publicity that has engendered is misleading, misinformed and distorts the facts. There has been an emotional outpouring of signatures on petitions, ignoring the facts, ignoring zoning issues, ignoring our Specific Plan and ignoring the truth.

Our neighboring community, Studio City, has urged its residents to sign petitions to "save the nursery" and urged Valley Village residents to do the same. The irony is that the Studio City Residents Association has come to Valley Village Homeowners Association for guidance in writing a specific plan for Studio City, using our Specific Plan as a template. Now they want us to make an exception to save (a small part of) the nursery!

We cannot and will not let our Specific Plan be destroyed. Once you hear all the facts, you will understand all the ramifications. We have worked long and hard to make Valley Village the livable, great and valuable community that it is. The emotional appeal of having a nursery should not persuade you into supporting a poorly conceived project.

Please come to the June 8<sup>th</sup> meeting and show your support for the Valley Village Specific Plan. Lori

PS: What gives us the assurance that a small nursery will survive? If it does not, the stage will have been set for a 45 foot high building on Riverside Drive. We must not let this happen. And another important fact: The Specific Plan calls for very extensive landscaping on new construction which must be followed. Do not be persuaded by the sentimental appeal of having a nursery into supporting an over size project that would destroy our Specific Plan.
