


participants, showing once more the value of Community Policing in connecting citizens with the Department.

On June 14th American Airlines added a 6:49am flight to Dallas and United Airlines offers a 6:40am flight to San Francisco.

The airlines try to justify these very early departures in order to accommodate customers booked on connecting flights at other airports. Many Valley residents fear that two curfew breakers will soon lead to more.



## **Neighborhood Council Pre-Election Information Meeting**

On Tuesday, July 22, Ginny Hatfield, Chair of the Neighborhood Council Valley Village (NCVV) Election Committee, along with fellow committee members Breice Reiner and Stuart Simen, attended the Board of Neighborhood Councils' (BONC) hearing at Sutter Middle School in Winnetka. NCVV was petitioning BONC for several changes to the by-laws, which were needed in order to proceed with the election of a Board of Governors. BONC approved the request and cleared the way for the scheduling of the elections that should take place in the fall.

Please mark **Thursday**, **August 21**<sup>st</sup>, on your calendar, as NCVV will be sponsoring a **Pre-Election Information Meeting** to discuss all aspects of the upcoming election. Candidate filing forms will be available for those who are interested in running for a seat on the Board, as well as copies of the by-laws and election procedures.
