Call to order at 7:00 pm by Chairman Mark Sander, also present were supervisors Jon Maker and Mark Labowski

Pledge to flag

Minutes from March 24, 2025 approved ~ Motion to accept/Mark L, 2nd Jon

ROADS AND EQUIPMENT: Stripped down truck 10, painted new barricades, fixed township building septic system (including updated instructions on where to find it), installed new toilet in men's room, call-out to Smith Street pump station, completed reflectivity tests on township road signs, trimmed trees, planed Mill Road

ZONING AND BUILDING: None

CORRESPONDENCE: PSATS notified us that state-mandated OSHA rules (HB299) may be in our future, depending on vote in Harrisburg

OLD BUSINESS:

- Aggregate bids opened: Allegheny Aggregate bid \$15.44/ton; IA Construction bid \$15.90/ton;
 Glenn O. Hawbaker Inc., bid \$19.33/ton and ACA Sand and Gravel bid \$15.22/ton. Mark S made a motion to accept Allegheny Aggregate bid, second by Mark L, all in favor
- Barricades built by students in the Career and Technical Center were picked up, thank you sent to Mr. Krasa and students

NEW BUSINESS:

- Township received a \$125,000 grant from Erie County toward our pump project
- Supervisors signed maps for Savko subdivision
- Documents were signed for seal coating of Hillcrest Drive by Suit-Kote; bidding for the project was part of a multi-municipal RFQ put together by engineer Mark Corey
- Supervisors discussed signing an intergovernmental cooperation agreement presented by Erie County, but voted to pass on it since EmergyCare already provides our EMS dispatching
- Supervisors signed the bid document from Seneca Mineral for our brine contract; originally awarded to Dodson Trucking, they didn't respond to our requests for several documents; Motion by Mark S., 2nd by Mark L, all in favor
- A Conelway Road resident asked the township about getting city water and/or sewage lines put in
 on their road; supervisors voted to authorize their engineer and the City of Corry to analyze cost
 and get back to us; secretary reported that letters were sent to Conelway Road residents, asking if
 they would be in favor of water and/or sewer lines being installed, an informal telephone poll with
 five residents showed three 'no' and two 'yes' votes; waiting on results of mailing for more input

- Mrs. Wellington told supervisors if we would tar and chip our roads and lower taxes, people would be more apt to build in the township
