

**WAYNE TOWNSHIP SUPERVISORS**  
**Minutes, April 28, 2025**

Call to order at 7:00 pm by Chairman Mark Sander, also present were supervisors Jon Maker and Mark Labowski

Pledge to flag

Minutes from March 24, 2025 approved ~ Motion to accept/Mark S, 2<sup>nd</sup>/Jon, all in favor

ROADS AND EQUIPMENT: Planed and graded Sciota Road, fixed washouts on Buffalo and Stateline Roads, changed tires on planer, fitted out both trucks to summer mode, cut grass

ZONING AND BUILDING: Three permits issued: a two-car garage, a three-car garage and a living room addition

CORRESPONDENCE: ECATO notified all members of an increase in fees to \$4,000 for filing a Uniform Construction Code (UCC) variance request

**OLD BUSINESS:**

- Turnpike Road/Messenger Road complaint: Trucking company using road for commercial hauling instead of original agricultural use, supervisors directed secretary to send a letter to the company advising them to contact our office to get the issue resolved
- Township ARPA funds year-end report filed and accepted
- Recycling event details were set: Saturday, June 21, 8 am to 1 pm at the Elgin Firehall, up to 24" tires from 8-12 noon, tractor tires from noon to 1 pm, no rims

**NEW BUSINESS:**

- Jeremy Bloeser, Executive Director of the Erie Land Bank spoke about the program, the benefits of the township being part of it and how their system works; supervisors asked questions and held a discussion, supervisor Labowski felt Erie County should not be in the business of buying and selling properties, supervisor Maker agreed, the vote was 2-1 not to join at this time

ACKNOWLEDGEMENT OF VISITORS: Lloyd Whitman, Gerri Wellington, William Wellington, Joseph Walton, Jeremy Bloeser, Frank Martin, Devon Martin

- Bill Wellington commented on the number of political, nonprofit and other signs erected in the township, most of them were for people not associated with the township (City of Corry), Mark S said he would get an answer on their placement
- Mr. Wellington also broached the subject of parking on the road during a recent auction; the roadmaster said the situation was addressed by the state police in a timely manner and resolved
- Lloyd Whitman asked why Corry was being included in the recycling event this year; Mark S explained they talked to us last year about maybe participating and decided to join this year
- Frank Martin told supervisors he's thinking of starting an organic material dump site on property he owns on Conelway Road, possibly to sell the compost, was looking for options and direction from the township; also thinking about a drop site for used appliances that he would recycle; unanswered question was how long would they be kept on-site, would need parameters
