**Minutes, January 13, 2025**

Call to order at 7:00 pm by Chairman Mark Sander, Jon Maker present, Mark Labowski absent

Pledge to flag

Minutes from December 23, 2024 and January 6, 2025 approved ~ Motion to accept, 2<sup>nd</sup>, approved

ROADS AND EQUIPMENT: Road crew plowed snow/salted, marked a collapsed culvert on Hereford Rd. with cones and a sign, general maintenance on equipment, mixed salt/sand in pit so it's ready, put new plow blade on the '08, ordered more sand and salt

ZONING AND BUILDING: Baker, four permits, moving mobile homes into Route 6 mobile home park

CORRESPONDENCE:

OLD BUSINESS:

- PennDOT call/contact list checked for accuracy, everything is current and correct

NEW BUSINESS:

- End of year zoning statistics: 39 permits issued, included were: (2) were postponed, (6) new homes, balance were additions/demolitions to homes or businesses, total zoning fees of \$2,445
- Supervisors voted to follow 2025 government mileage guideline of \$.70/mile; Motion to accept, 2<sup>nd</sup>, approved
- 2025 administrative fees approved: Wayne Township Sewer Authority \$150/administrative service; CREMA admin fee of \$7 approved, but township will talk to them about an increase; Motion to accept, 2<sup>nd</sup>, approved
- Fast check authorization #25-03 approved; Motion, 2<sup>nd</sup>, approved
- Fee resolution #25-04 approved with change of percentage; Motion, 2<sup>nd</sup>, approved
- County Aid Application Resolution #25-05 approved; Motion, 2<sup>nd</sup>, approved
- Barricades were discussed, sometimes cones marking a danger area are stolen, barricades might help, tabled in favor of having maintenance crew build them
- Copier quotes submitted for discussion, at end of 2025 maker will stop making replacement parts for current one ; supervisors asked secretary to get pricing on renting a copier instead of buying
- Real estate billing postage costs submitted by tax collector with three options: (a) Option 1: total cost \$771.75 (no history with this option); Option 2: total cost \$956.25 (Printing Concepts); Option 3: Tax collector purchases/attaches/mails at total cost of \$821.25 and is reimbursed. Supervisors voted for Option 3; Motion, 2<sup>nd</sup>, approved

- Mr. Wellington asked about progress of zoning plan, Mark Sander explained we are still waiting on city for update because we are currently partnered in their plan; Mr. Wellington noted the intersection of Hereford and Sciota Roads is too narrow, Mark explained our drivers are doing their very best; Mr. Wellington also complained about the "V" shape of snow left at intersections
