OLD BUSINESS

Enchanted Beginnings was sent the determination from the March 23, 2022 Zoning Hearing on May 5th. At this time, Dan or Cheryl Moore has not been in to complete the zoning application.

Richard A. Warner moved, Mark L. seconded to award the contract to A.C.A Sand and Gravel in the amount of \$17,780.40. All voted, yes.

Building Inspection Underwriters contract will expire July 10, 2022. The secretary made mention that if the Board of Supervisors wish to explore other avenues, a bid package and proper advertisement will need to occur before official action can take place.  
Richard A. Warner and Mark M. Sander spoke out of putting the information together.

Richard A. Warner and Mark A. Labowski moved to add application for Emergency Liquid Fuel funding to the agenda. All in favor to open up for discussion.

On May 21, Wayne Township received an exceptional amount of rain throughout the evening. Many township roads were compromised with the loss of gravel. It is with a best guesstimate that there were two miles of gravel lost in the storm. Tomorrow, Tuesday, Richard A. Warner will travel township roads with the ECATO committee. At that time they will have a better handle on the loss.

Erin Bisbee will make application for emergency funding to be presented at an ECATO meeting on Wednesday, May 25<sup>th</sup> 2022. The funding is a 50/50 match and the township would have to contribute \$75,104 (two miles, equipment and labor) if the determination is two miles of roads. All voted, yes.
