Call to order at 7:00 pm by Chairman Mark Sander, also in attendance supervisors Jon Maker and Mark Labowski, maintenance crew Logan Mather and Jaxon Gray

- Complaint by Mrs. Wellington, no agenda on the website prior to meeting
- Complaint by Mrs. Wellington, uniforms may have been budgeted, but prior to formal vote supervisors agreed costs would be taken out of employee pay if approved
- Supervisors were asked if they still had an agility agreement with PennDOT; current one expires in June 2024 and will be handled
- Supervisors were asked why can't township use liquid fuels money for brine (state rule that it can only be used for construction, reconstruction, maintenance and repair of public roads)
