ROADS AND EQUIPMENT: W. Smith street patching, filling holes, general maintenance work on roads, equipment

ZONING AND BUILDING: Lee (billboard), 24-03 Donato carport, 24-04 Schetter (steps, platform, dormer roof)

**OLD BUSINESS:**

- Attorney Agresti sent out street light liens, mailed April 15, must give recipients 30 days before followup action can be taken (May 15)
- Liquid fuels audit 100% complete; an error we made in 2021 was corrected in 2022, no action needed by township
- Made note of error by secretary in reporting hourly fee (\$250) for Gery Nietupski (sewer authority attorney) ~ is \$125/hour
- Door lock quote by Rande Joy ~ 11 lock cylinders @ \$18/each; rims/mortises as needed \$30/cylinder; code-cut-stamp new keys \$6/key; labor to remove, reinstall, lube and adjust \$40/hour not to exceed \$400. Supervisors Maker/Sanders voted to accept quote, Labowski voted no (based on open-ended labor cost)

**NEW BUSINESS:**

- Tire recycling event will be held June 8, 8 am to 1 pm at the Elgin Beaverdam VFD, includes Concord Twp., Elgin Borough; supervisors discussed how many tires can be dropped off per household (10), no tractor tires, tires up to 22", no semi tires; trying to locate local hauler who recycles tires, so township would be eligible for grant to refund percentage of cost from state
- Received last reimbursement for Mill Road Bridge project (\$161,433)
- Sewage complaint from residents of trailer park on Route 6, drainage from home on King Road; issue referred to DEP which will investigate
- Zoning officer Phil Conklin recommended to supervisors they add the word "permanent" to Section 503.2 of township zoning ordinance, so it reads "...including porches, permanent carports..."; supervisors agreed to change wording when township does broad update of zoning ordinance
- PA governor signed bill authorizing pay raise for township auditors by resolution from \$10/hour to up to \$18/hour for performing annual audit in January

BILLS AND PAYROLL: checks for payroll and invoices for General/Sewer funds signed
