WAYNE TOWNSHIP SUPERVISORS Minutes, July 8, 2024

Call to order at 7:00 pm by Chairman Mark Sander, supervisors Jon Maker and Mark Labowski

- Anita Baker, Wayne Twp. tax collector, spoke about assisting in research that led to the
 end of our per capita tax and combining the street light assessment into the township
 and county tax bills, and how it helps homeowners who escrow their taxes
- She advised the supervisors that the tax collector convention 2024 is in Camp Hill, PA
 October 11-12 and is hoping to share expenses/hotel room with the Concord Township
 tax collector
- Anita also brought up the many complaints/concerns she has fielded from people
 entering/exiting her driveway. She has called PennDOT (state highway) and the local
 representative visited the site. The Bryants are members of the trust that owns this
 property and are relatives of the Bakers. They have tried repeatedly to get the person
 who represents the trust to mow/remove debris and front yard was finally mowed. Mark
 Sander advised the secretary to prepare a nuisance ordinance letter to the trust that will
 be posted at the site, giving it 20 days to respond before further action is taken.
- Lloyd Whitman brought up the issue of Elgin Beaverdam Fire Department's ownership of 'Station 2' property on Sciota Road again. He alleges the property has never been used as a fire station and is tax-exempt, that they are hiding behind the tax-exempt status and believes the fire department should be pushed to sell it to get the property back on tax rolls. The secretary reported she spoke to several people who were involved with the township when the land was donated to the fire department. This was a private deal, the township cannot 'force' the fire department to do anything, and the impact on the tax base would not be significant.
- John Tobin reported he offered to help the owner of a property on Hare Creek Road, which was recently posted with a nuisance warning letter, clean it up, but there has been little to no response to his offer.

NEW BUSINESS:

- The township has submitted a request for an additional reimbursement for the Mill Road Bridge project of \$15,756.84 after the contractor and engineer submitted an unexpected change order, increasing overall costs
- Supervisors discussed extending a water line on the north side of Hare Creek Road; they
 reported that the city of Corry is considering enacting an ordinance that requires any
 new add-ons to have both water and sewer, not one or the other; the Corry maintenance
 manager will provide prices to the township to extend the line
