- a. Tree branches need to be trimmed on Russell Rd.; also, water is running down the road and causing it to wash out
- b. Supervisors were asked if the township was still brining roads and were thanked for revamping the permits to use roads for hauling
- c. Supervisors were asked why they met in executive session before the regular meeting ~ the answer was that there was no executive session, only that there were supervisors in the same room at the same time before a meeting
- d. Supervisors were asked about the status of a building designated as 'station 2' for the Elgin fire department that appeared to have never been used for that purpose, and said it should be 'declassified' and returned to landowner

OLD BUSINESS:

- a. Township not eligible for 50% grant from state for tire recycling, because tires are shredded and landfilled by ProWaste Services
- b. Girts Sand and Gravel awarded antiskid contract for 800 tons at \$8.75/ton
- c. Mill Road bridge start is still 1-2 weeks out

NEW BUSINESS:

- a. Dan Moore inquired about changing the polling place for Wayne Township to Enchanted Beginnings; even though supervisors have no say in polling locations, two of three supervisors spoke out against moving it
- b. Secretary requested permission to contact district justice to initiate proceedings to collect about \$6,000 in overdue water/sewer bills from a local resident
- c. Quote from Rossbacher Insurance for the township's general liability insurance discussed; supervisors decided to stay with PIRMA coverage
- d. Tax collector Anita Baker asked permission to store three boxes with old tax returns/information at the township building, OK'd by supervisors

- e. Supervisors voted to advertise for a used backhoe, accepting bids until 10 am on the day of their next meeting (Sept. 11); posted in the Journal and on our Facebook page
- f. Evaluations done on maintenance employees, results are Logan Mather has been appointed Interim Road Master, effective until the January 2024 reorganizational meeting, with a pay raise of \$1.25/hour equaling \$20.88/hour; Jaxon Gray's yearly evaluation was completed and he was given a \$1.00/hour pay raise, equaling \$19.36/hour
