Minutes from January 3 meeting were approved by Supervisors

Concerns voiced by visitors:

- a. Mr. Wellington voiced his concerns about the path snowmobiles are taking near the Country Club ~ when the machines crest a hill, they are on the wrong side of the path, presents a hazard to sleds coming from other direction; they don't have permission to use this route. Supervisors advised him to contact TriCounty Snowblazers' Jason Christensen.
- b. Mrs. Wellington asked if the township could have a zoning officer and not have an enforcement officer, supervisor explained our zoning officer works for several entities, the township addresses any questions/problems after initial zoning request.
- c. Mrs. Wellington asked for explanation of Township Act 57 Resolution ~ requires taxing districts in PA to waive additional charges for real estate taxes in certain situations.

- a. Backhoe returned to building, working fine now, no problems (2002, 3,100 hours)

NEW BUSINESS:

- a. Resolutions adopted (motions by Warner, seconds by Sander, Labowski):
