

**WAYNE TOWNSHIP SUPERVISORS**  
**Minutes, November 10, 2025**

Call to order at 7:00 pm by Chairman Mark Sander, also present were Supervisors Jon Maker and Mark Labowski

Pledge to flag

Minutes from October 27, 2025 approved ~ Motion to accept/Mark S, second/Jon, all in favor

ROADS AND EQUIPMENT: Roadmaster ~ Put plow markers out, got all sand and antiskid delivered and mixed, both plow trucks ready to go but one is going out to get brakes this week, put part in loader, changed differential fluid and hub oil, normal machine and facility maintenance

ZONING AND BUILDING: None

CORRESPONDENCE: PSATS sent new contribution rate schedule for 2026 and DCED sent a list of filing dates for various tax forms and paperwork

OLD BUSINESS:

- Local Share Account (LSA) grant ready to be filed after resolution signed

NEW BUSINESS:

- Resolution 25-11 signed by supervisors, authorizing township to apply for the LSA grant cycle 2025-2026, grant would be used to purchase a new truck; still waiting to hear about last year's grant ~ Mark S/motion, Mark L/second, all in favor
- 2026 CREMA (Coneway Regional Emergency Management Agency) budget presented for discussion, Wayne Township's share is \$1,957.46, supervisors voted to approve, Mark S/motion, Jon/2nd, all in favor
- New health/dental insurance renewal figures: current total premium is \$780.04 with a \$750 deductible; new figures for the same plan ~ with a 15% increase and \$750 deductible (dental premium stays the same), would go to \$891.10/month ~ same plan with an 11% increase and \$1,250 deductible (dental premium stays the same) would go to \$857.10/month; after discussion, supervisors agreed to keep the current plan with a 15% increase and \$750 deductible; motion/Mark S, 2<sup>nd</sup>, Jon, all in favor
- New copier ~ CoStars pricing to buy a new copier outright would be \$2,785 plus cost of black/white and color copies, leasing a copier would be \$78/month plus cost of copies; motion by Mark S., 2nd by Mark L., all in favor to buy a copier outright
- Diesel fuel bids ~ supervisors authorized the secretary to solicit bids for fuel for 2026
- Supervisors discussed a tax increase for 2026, all agreed the township can hold the current rate for another year at 1.24

ACKNOWLEDGEMENT OF VISITORS: Ray Wiggers, William Wellington, Rebekah Wallace/Corry Journal

- Mr. Wiggers asked how long the township has held the rate of 1.24
- Mr. Wellington again brought up our affiliation with PSATS and the advice they give government entities in PA, specifically whether we have to advertise a vote on resolutions, supervisors explained again we're doing it correctly
- Mr. Wellington detailed his request for information from the township under the Right To Know Act, which was ultimately denied at the state level and doesn't understand why he had to file the RTK request at all or 'all the secrecy'
- Mr. Wellington said he has a good source at the city who told him nothing had been done to the city's portion of his road (Random) because the township refused to do anything on their end; supervisors explained we maintain all of our roads to the best of our ability, and have a wish list of roads that need attention, are applying for grants to help for specific projects and trying to run the township efficiently; Mr. Wellington said he offered to pay to have his portion of Random Road tarred and chipped or oiled, but the township didn't follow up on it

- Mr. Wiggers complimented our township and its road crew on the condition of our dirt roads
- Mr. Wellington asked when the public could get a copy of the budget
