When should I renew my DACA?

You can renew 120-150 days before your EAD expiration date.

The NATIONAL IMMIGRATION LAW CENTER has provided us with a calculator by simply putting your expiration date of your current Employement Authorization Document it will give you a date when they recommend you to renew.








- Do not print out the applications double sided, only one side, USCIS will reject your forms.

THE SWEET WAITING TIME

Congratulations! You are ready to send your renewal, send it a certified PRIORITY EXPRESS MAIL (1-2 days guaranteed or your money back, visit USPS to see the cost) and now we will have to wait patiently for a response or for them to ask you for more documents/evidence.

The waiting time is currently 3-5 months, but is subject to change with the influx of requests, remember that this is why you do it in advance.

- Stay up to date with your case in case they send you an appointment for the hueyas or ask you for any evidence.
- Sign up for USPS Informed Delivery, don't miss your mail.
- If your address moves, please update USCIS immediately!
- If your case lasts more than 105 days without approval, you can make an inquiry with USCIS by calling the number **1(800) 375-5283.**
- If your case lasts more than 120 days without approval you can contact your congressman for help, visit: https://www.house.gov/representatives

The most important thing is to renew with time! Please don't let your DACA expire!
