### Who can obtain Parole In Place?

If you are the spouse, parents or children (under 21 but unmarried) of:

- An active member of the US Armed forces
- A member off the Reserves or National Guard
- A Military Veteran

\*if deceased, as long aS not dishonorably discharged

No significant criminal record

The applicant MUST have entered the United States illegally.

legal entry ( you were inspected at port of entry) applicants do not qualify for Military PIp but may qualify for military deferred action.

 You must handwrite "Military PIP" in Part 2 instead of checking a box;

a pdf guide is in the files for how to fill out the pip form I-130, which yes it's the same as advance parole, document to travel outside the usa, but no you cannot travel once your pip is granted, you must file your aos within the 1 year of your pip, as it does expire!

### EVIDENCE

Gather evidence to prove relationship to service member Examples of evidence to include if you are the SPOUSE of an active service member or a veteran :

- copy of marriage license/ certificate
- evidence of bonafide marriage, not alot iS needed but please show your marriage is true
  - birth certificate of children
  - financial records, bank accouts, taxes
  - Utility Bills
  - any photographs with special dates

\*not all evidence applies to your case, these are examples

### EVIDENCE

Gather evidence to prove relationship to service member

Examples of evidence to include if you are the PARENT or CHILD of an active service member or a veteran :

- copy of the child's birth certificate or adoption decree
- if stepchild, marriage certificate of parents, remember marriage had to have happened when child was under 18
- evidence showing the child was legitimated/recognized
  - financial support was provided, so any receipts
  - any photographS

STEP 3: GATHER Evidence of a Family Relationship to Service Member

YOU WILL NOW NEED TO PROVE THAT petitioner iS a US CITIZEN :

- copy of Birth certificate
- naturalization certificate,
- certificate of citizenship,
- unexpired U.S. passport or consular report of birth abroad

PROVE THAT petitioner iS a Permanent Resident, if applies:

- Submit a copy of a green card
- Form I-797 indicating a grant of permanent residence,
- or unexpired Form I-551 stamp in a passport

### WEAREDREAMERS NETWORK PAROLE IN PLACE STEP BY STEP GUIDE EVIDENCE

YOU WILL NOW NEED TO PROVE THAT THEY SERVED :

- copy of any militrary orders
- copy of military id, front and back
  - DD Form 1173 can be obtained through the National Archives Website
- copy of any Awards or commendations the military service member has received
- cOPY Proof of enrollment in the Defense Enrollment Eligibility Reporting System (DEERS)


#### COPY OF WORK CARD \*IF ANY

- 2x2 passport photos
- copy of YOUR BIRTH CERTIFICATE with english translation
- letter of hardship & LETTER OF GOOD 2
   MORAL CHARACTER
  - such as letters from community leaders or teachers showing involvement in volunteer, community or educational activities).
- criminal despositions, IF ANY
- letter of entry into the usa/ Statement about Last Entry
- proof of status-IF ANY (SOME PEOPLE HAVE DACA BUT NEED PIP TO ADJUST)



2x2 PASSPORT PHOTOS \*REQUIRED!

COPY OF YOUR SOCIAL SECURITY \*IF ANY



Birth certificate with English translation \*REQUIRED!



### STEP BY STEP GUIDE ORGANIZE & PRESENT

USCIS FIELD OFFICE

To request parole in place, you must submit the following to the USCIS office with jurisdiction over your place of residence, your home, your address. USCIS field offices do not allow walk-ins. You must have an appointment to visit an office, but mailing it to them via **Priority Express Mail** works too. Search by ZIP code: https://www.uscis.gov/about-us/find-a-uscis-office/field-offices



\*\*\*Military families on assignment in an area different from their permanent place of residence may submit their request to the office with jurisdiction over either location
