

## CERTIFICATE OF CONFORMITY WITH IFRA STANDARDS

| IFRA Category 12  | Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragancing sachets, incense, liquid refills (cartridge), air freshening crystals, solid non aerosol car diffuser); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact (e.g., fabric drying machine deodorizers, carpet powders); Dry cleaning kits (placed in the dryer); Dryer sheets and fabric softener sheets; Fuels; Insecticides (e.g., mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers – for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (toilet); Toilet gel; Scent beads |
