MOUNTAIN VIEW WATER LTD.

Council contacted Mountain View Water Ltd. To discuss an agreement to do the water testing at the Village of Morrin water distribution plant. Mountain View only do testing one day per week on Mondays.

Mountain View Water Ltd. Would not be considered as the certified or attending operator for the water distribution system, but will serve as manpower to assist with the sample collection.

As per the village of Morrin Water License, testing needs to be done on a daily basis. The village will need a daily operator for water testing.


C26-024 Motion: Deputy Mayor Dragani motioned that the village hire Mountain View Water for six months at \$ 485.00 per week.
