



1. CALL TO ORDER

Mayor MacArthur called the meeting to order at 10:00 A.M.

2. ITEM FOR DISCUSSION: C-CANS ON BLUMING PRAIRIE SITE/C-CAN ON KEN DEVALERIOLA RESIDENTIAL PROPERTY.

Darrin Sherwood- Bluming Prairie Developments and Ken Devaleriola attended the meeting to discuss with Council the C-Cans on these properties. The Bluming Prairie site was designated for U-Hauls. Ken Devaleriola property is residential and the Land Use Bylaw does not allow C-Cans on residential properties.

Mayor MacArthur requested an explanation for the C-Cans on these properties. Mr. Sherwood explained that the reason for the two C-Cans on the Bluming Prairie site was for storage for snow removal equipment and U Haul supplies. Mr. Devaleriola was requested to remove the C-Can from the residential area immediately.

Bluming Prairie Developments advised Council and CAO that they were "planning" on submitting a new rezoning application through Palliser Planning Commission and that Council would consider that application when it was received, noting that the application was being submitted before the 12 month deadline and that the Council would have to approve the timing of the application before processing could begin.

C25-135 – Motion: Mayor MacArthur motioned that the Village grant permission for the Bluming Prairie to place two C-Cans on the site in order to store snow removal equipment and U-Haul supplies until June 1, 2026 and Ken Devaleriola will remove the one pitched roof C-Can from the residential property and place it at the Bluming Prairie site, one of the two C-Cans presently at the Bluming Prairie site will be removed.

Carried Unanimously.

BULK WATER SYSTEM FILL

Council discussed purchasing a card lock system from ConX Wireless for the Village bulk water. This is the same system that Starland County are putting into all their bulk water facilities.

C25-136 Motion: Deputy Mayor Edwards motioned that the Village purchase the ConX Wireless system for the bulk water for the cost of \$ 9,581.25
