

Election of Officers for 2018

Here's how the Bylaws define our election that takes place at the Annual Meeting to be held Dec. 16th at Jack's house. "During the month of September, the Board may elect a Nominating Committee consisting of three (3) members and two (2) alternates, not more than one of whom shall be a member of the Board. The committee shall nominate one (1) candidate for each office and five (5) candidates for the five (5) other positions on the Board, and after securing the consent of each person so nominated, shall immediately report their nominations to the Secretary in writing by October 15. Upon receipt of the Nominating Committee's report, the Secretary shall, before November 1, notify each member in writing of the candidates so nominated. Additional nominations may be made at any meeting held prior to November 20 or in writing by November 20, provided that the person so nominated accepts when his or her name is proposed, and provided further that if the proposed candidate is not in attendance at this meeting, his or her proposer shall present to the Secretary a written statement from the proposed candidate signifying his or her willingness to be a candidate."

DUES

There has been some confusion about when dues must be paid. Here are the rules as stated in the Bylaws: "The amount of the annual dues shall be determined by the Board of Directors and approved by members, payable on or before the 1st day of January of each year. No member may vote whose dues are not paid for the current year. During the month of November the Treasurer shall send to each member a statement of his dues for the ensuing year." The confusion comes from the section of the Bylaws that states: "A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid 90 days after the first day of the fiscal year; however, the Board may grant an additional 90 days of grace to such delinquent members in meritorious cases. In no case may a person be entitled to vote at any Club meeting whose dues are unpaid as of the date of that meeting." So, the bottom line is if your dues are not paid by Jan. 1, 2018 then you cannot vote until they are paid and you have until March 31 to pay them without losing your membership.

STANDING RULES

TREASURER

An informal audit will be performed every year if the Treasurer has not changed during that time frame.

An informal audit will be performed at each change of Treasurer.

TROPHIES

Perpetual Trophies

Legal ownership of all perpetual trophies is to be retained by the club until terms of possession have been met. If possible, the trophy will remain in the care and custody of the donor, who shall be responsible for bringing the trophy to the specialty. If the donor is deceased, or out of the area, the club will maintain possession with no liability for loss, damage, or destruction of the trophy. All new perpetual trophies must be approved by The ECSCSC Board before being offered.

Donations

All trophy donations will be acknowledged in the catalog, if possible, when payment is received by the club, by catalogue submission deadline date.

INSURANCE

The club is to carry General Liability Insurance at all times.

ELECTRONIC MAIL

Electronic mail may be used for club business and deemed acceptable for all cases that require written correspondence per the Constitution and Bylaws. Except for special circumstances, as approved by the Board, electronic mail shall not be used for voting submission.

JUDGES

Selection Procedures

Objective: To nominate judges for our Specialties that are fairly determined by the membership and done in a timely way to meet the constraints of partner clubs and considering the financial impact to the Club.

Selection Procedures (con't)

Principles:

- 1. No vote shall take place without prior written notice to the membership AND A MEMBER MUST BE PRESENT AT THE MEETING TO VOTE.
- 2. Notification must be sent to the membership at least 10 days in advance of a meeting when a judges vote and/or nominations will take place.
- 3. Nominations of judges will be accepted by email. Notification of nomination period will be sent by email to members and the nomination period will be for a minimum of 10 days.
- 4. Only licensed AKC judges are eligible to judge regular classes at our Specialties. Non-licensed judges are eligible to judge Sweepstakes.
- 5. Voting for the judges shall take place at the January and July meetings IF POSSIBLE.
- 6. If we have the Seaside Spectacular panel available for the July meeting, we will vote in July for Breed and Sweepstakes for the July Specialty. A nomination period for this purpose will be opened in advance of the July meeting. If no vote takes place at the July meeting, any nominations made will be held for the meeting where the actual vote occurs.
- 7. If a partner club's judges are available, the list shall be provided to the members and consideration should be given to select judges from those panels to minimize the cost impact to the Club. But in no way should this be considered as binding. Use of a panel judge should be given greater consideration for our Winter Specialty, due to entries being typically lower than the Summer Specialty. List will be sent out within seven days of receipt.
- 8. Consideration should be given to the timing requirements of our partner clubs so that we strive to meet their schedule to provide to them our preferred judges well in advance; not the other way around. We should establish and maintain an agreement in principle with our partner clubs, that if we provide them with the name of our preferred judge in advance of their panel being finalized, they will give full and reasonable consideration to adding that judge to the panel.
- 9. In any vote, 3 choices should be made. The order of preference shall be determined by the number of votes earned (per the voting procedure outlined below). However, under no circumstances shall a nominee be included if they earn less than 5 votes.
- 10. If an additional ballot is required to determine the top 3 vote getters, then it shall be done at the same meeting as when the original vote is taken. In case of a tie, another vote shall be taken. In the event that a tie continues, the judge selection will be moved to the next club meeting, if necessary or a special meeting will be called.
- 11. Judges should be contacted in order of the list resulting from the members vote.
- 12. Voting of judges at our meetings shall be conducted by secret ballot in two rounds. In the first round, each voting member will be given a ballot on which they can select up to three names. Votes will be tallied and the top three vote getters determined. Each voting member will then be given a second ballot on which they can select one of the three top vote getters. These votes will be tallied to determine the order of preference.
- 13. These voting procedures apply to selection of regular conformation and sweepstakes judges.

 Obedience judges are selected by the performance committee. Any interested member can join the performance committee.
- 14. Partner clubs are defined as all-breed clubs holding shows on the same weekend and show site as our Specialties.
