BOARD DECISIONS

Often time the Board must make decisions between Board meetings and therefore these decisions would not be in any minutes but are announced in this section of the Courier. Activities this period:

1. The following motion was approved by the Board for the election of officers for the year 2021. This special process was approved for this year only:

In lieu of the Annual Meeting to be held in December per the By-Laws, I move that due to COVID-19 restrictions we adopt an interim/temporary process to allow the election of Officers and Directors for the year 2021 to be done by email. On Dec. 1, 2020 the Secretary will e-mail each member the slate of officers developed by the Nominating Committee and any additional nominations from the membership and ask each member to vote by email 'Approving' or 'Disapproving' the slate presented or voting for individuals if there is more than one nomination for a position. Each member must email their vote to the Secretary by December 15, 2020. The Secretary will then inform the membership the results of the election. At least 11 votes (20% of the membership) must be cast with the majority to rule.

DUES: DON'T FORGET THAT DUES FOR THE CALENDAR YEAR 2021 MUST BE PAID BY DECEMBER 31, 2020. Per the by-laws anyone who has not paid their dues by this date cannot vote on club business starting on Jan. 1, 2021 and if DUES ARE NOT PAID BY MARCH 31, 2021 YOU WILL HAVE TO REAPPLY FOR MEMBERSHIP. Dues are:

\$25 for single Regular Membership plus \$5 for each additional household member

\$20 for Subscriber Membership (same privileges as Regular Member except no voting rights, cannot hold office and not counted to determine quorum)

\$15 for Junior Membership (anyone under the age of 18)

Mail checks made out to ECSCSC and marked as dues to Jack Pettee
