#### **RESEARCH INTO CANINE ADDISON'S DISEASE THAT DOES AFFECT ECS**

Hello Everyone. My name is Amy Treeful and I am a graduate student helping Dr. Steven Friedenberg at the University of Minnesota with his research on canine Addison's Disease. In addition to our ongoing genetic study, which some of you may have participated in, we have launched a study to identify the autoantibodies in canine Addison's Disease. Identifying the disease-defining autoantibodies would help to develop an early screening test for Addison's Disease in at risk populations. Such a test exists for humans, but has not yet been established for dogs. This kind of test could help find Addison's cases before considerable suffering and disease progression occurs.

Because the component of the blood to be studied is different in the new study (antibodies), we can't use previously submitted blood samples from the genetic study. Blood samples for the genetic study were used to isolate DNA only and the new study requires the blood be collected into three different special tubes. If you are unsure if you have participated in either of these studies and would like to clarify with me, please feel free to contact me at tree0002@umn.edu. I can check our records.

If you would consider it, we would be grateful if you could send a one-time blood sample to be collected at your at your veterinary clinic. We are specifically looking at this disease in a selection of predisposed breeds, specifically, Standard Poodles, Portuguese Water Dogs, and English Cocker Spaniels. We currently are in the greatest need of samples from English Cocker Spaniels. The four groups we are looking for are as follows;

Newly diagnosed dogs with typical Addison's Disease (Sample collected within 30 days of diagnosis)
Long-term cases (Ideally diagnosed 5 years ago or longer, but we have relaxed this criteria. If you have a dog living with typical Addison's Disease for more than one year, we would still encourage you to participate.)

3) Healthy dogs ages 8 or older (no other existing autoimmune disease or illness)

4) Young healthy dogs ages 3 or younger (no other existing autoimmune disease or illness)

I also want to add that we in our studies we have noticed that English Cocker Spaniels tend to have lower baseline cortisol levels than the other breeds in this study. This does not mean that your pet has Addison's Disease. However, it would mean that in order to include the pet in the study we would have to follow up with an ACTH stim test (which is of very low risk) to establish normal cortisol production. This is something that we would arrange with your veterinary clinic with your consent and we would pay for it (as long as it is within our budget).

If you are interested, please contact me at tree0002@umn.edu. I would just need the contact information for your veterinary clinic so that I could send them a collection kit. I would also give them a call ahead of time to let them know to expect the kit and to discuss the study. The collection kit includes the collection instructions and tubes, return packaging materials, and a prepaid return FedEx shipping label. Most vets will agree to do the blood draw free of charge because it is for research but I highly recommend confirming this with your clinic prior to the blood draw.
