The Project includes the following Work:

The Project consists of constructing an approximately 2.7-acre Type-II landfill cell using a double-composite geosynthetic clay liner (GCL) and HDPE liner system.

Bids are requested for the following Contract: Cell C Phase I Construction

Owner anticipates that the Project's total bid price will be approximately \$1,900,000. The Project has an expected duration of 120 days.
