#### **EVENT DETAILS**

Vendor Eligibility. Vendors offering pet-related products, services, or community engagement are encouraged to apply. Acceptance will be based on appropriateness, uniqueness, and contribution to the event, as determined by the organizers.

#### **BOOTH DETAILS**

- Standard booth size: 10' x 10'.
- Vendors may request additional spaces (if available).
- Booths are assigned in order of application and availability.
- Booth sharing is allowed with prior approval & completed applications from all parties.
- Signage and displays must remain within booth boundaries unless approved in advance.
- Vendors supply all required equipment, including canopy (weights), tables, displays, etc.
- No electricity or water will be provided.
- Booths must be staffed for the full duration: 10:00 a.m. to 2:00 p.m.

#### **SETUP & BREAKDOWN**

- Vendor check-in begins at 9:00 a.m. at your assigned booth location (TBD).
- Tear-down starts at 2:00 p.m. (no earlier) and must be completed by 3:00 p.m.
- Vendors are responsible for leaving their area clean and removing all debris.

### **RESTRICTIONS & REGULATIONS**

- No alcohol, cannabis, or controlled substances permitted.
- All vendors must comply with safety codes and community standards.
- All animals must be leashed or contained at all times.
- This is a rain-or-shine event—vendors should come prepared for all weather conditions.
- Event organizers reserve the right to remove vendors who do not comply with guidelines or create unsafe conditions.



#### APPLICATION & FEES

- Booth Fee: \$125 per 10' x 10' space (no application fee).
- Payment: Due upon approval via Venmo (details will be provided).
- Sponsorship Add-Ons: Available; ask about category exclusivity.
- Prize Donation: One minimum raffle prize item is required, to benefit Oregon Dog Rescue.
- Refunds: No refunds for cancellations within one week of the event.
- Licensing: All vendors must complete a Transient Merchant Vendor Permit from the City of Gladstone.

Vendors are fully responsible for their own property, conduct, and products. The City of Gladstone and Clackamas County are not liable for damage, loss, or injury.

# TRANSIENT MERCHANT VENDOR PERMIT (TMV)

A Transient Merchant Vendor (TMV) permit is a temporary business license that allows a person or company to sell goods/services at events or pop-ups.

#### **ALL VENDORS MUST:**

- Complete the TMV application (found at the City of Gladstone's website)
- Submit a copy of a valid government-issued photo ID
- Pay the TMV fee
- Email completed forms to <u>bl@ci.gladstone.or.us</u> or drop off at City Hall, 18505 Portland Ave., Gladstone, OR
- Payment can also be made online (see website for instructions)

#### FOOD TRUCKS

- Additional documentation is required for mobile food vendors:
- Current Clackamas County Health Permit
- Completed TMV application
- Photo ID for each team member working at the event
- Completed Clackamas Fire Mobile Food Unit Application
- Written property owner permission (if parking on private land)

#### **FOOD TRUCKS MUST ALSO:**

- Be equipped with a Class K fire extinguisher
- Remain mobile and cannot park overnight
- Operate only during public park hours
