Course Overview

This course examines how individuals form and express political attitudes and how these attitudes influence political life. We will explore key areas of public opinion including political ideology and polarization, political knowledge and misinformation, trust in democratic institutions, views on inequality and redistribution, attitudes toward immigration and multiculturalism, climate change and environmental policy, and perspectives on crime and punishment. The course considers the social, economic, and cultural forces that shape political views and how these views translate into political participation, voting behavior, and policy outcomes. Students will engage with empirical research, real-world case studies, and guided discussions to critically evaluate competing explanations for public opinion patterns and to understand the implications for democratic governance and how political attitudes change over time.

Course Objectives

There will be several goals that this course will focus upon; among them are:

- 1. To understand how political attitudes are formed and expressed.
- 2. To become familiar with major theories and concepts related to public opinion.
- 3. To be able to articulate how political attitudes influence participation, voting behavior, and policy outcomes.
- 4. To master basic empirical facts about public opinion in contemporary politics.
- 5. To understand how political attitudes vary across demographic groups and political contexts.
- 6. To learn to critically evaluate empirical research on political attitudes.
- 7. To develop the ability to interpret and discuss real-world cases and current events through the lens of public opinion research.
