



DID YOU KNOW? Missouri is at the center of the national fight for reproductive freedom. We were the first state to ban abortion after *Dobbs*, and with the passage of a constitutional amendment in 2024, the first to overturn a total ban. The amendment expands access beyond what existed under *Roe* for patients across the Midwest including in six hostile neighboring states and Kansas, where access remains fragile.

Every statewide office and the legislative supermajority are held by anti-repro officials, and lawmakers have already advanced a deceptive ballot measure to repeal our rights. Without a change in control, our hard-won protections remain at risk.

Access MO is at a critical inflection point. With additional support, we can help break the anti-reproductive rights supermajorities in 2026, strengthening the defense of reproductive freedom and opening the door to even greater progress. **The stakes are high, but so are the opportunities.**

WHO IS ACCESS MO?

Access MO is a locally led, statewide, nonpartisan PAC that is building political power to defend constitutional rights, safeguard reproductive freedom, and win legislative and statewide offices for lasting change.

We are trusted leaders, backed by a board of former legislators, political consultants, physicians, lawyers and grassroots organizers with experience from Planned Parenthood, ACLU of Missouri, Center for Reproductive Rights, and NCJW St. Louis. Through our multi-faith Clergy Advisory Board and coalition building, we broaden support and activate new communities across Missouri.

Access MO is powered by a strong, growing donor base — more than 60 major donors, 400+ individual statewide donors, and a national funder — all committed to sustaining this fight.

OUR TRACK RECORD OF IMPACT

Legislative victories: In 2022, we gained three pro-repro seats in the Missouri House creating the largest pro-repro caucus in a decade. In 2024, while other states lost state legislative seats, we maintained our margins.

Constitutional amendment victory in 2024: A driving force behind enshrining the constitutional right to reproductive healthcare in Missouri.

Healthcare Professionals for Reproductive Rights Coalition: Helped build a statewide network of more than 400 medical professionals to counter misinformation, amplify trusted voices, and power the constitutional amendment.

Redistricting influence: Strategically engaged in statewide redistricting that created competitive swing districts in both the Missouri House and Senate.

THE ROAD AHEAD IN MO: 2026 AND BEYOND

In 2026, we can break the anti-reproductive rights supermajorities and expand on these wins in 2028:

Missouri Senate (34 seats):

Only 2 flips needed.

Missouri House (163 seats):

Only 3 flips needed (with 2 current vacancies).

Seven senators and 33 house members voted to reinstate the ban when their constituents voted to eliminate it. This shows that incumbents are out of step with their constituents.

Target senate races in 2026:

SD 2 (St. Charles):

Sen. Nick Schroer opposed access; 50.75% supported access.

SD 8 (Kansas City area):

Open seat; 57.89% supported access. Rep. Keri Ingle flipped her house seat and can win this race.

SD 30 (Springfield):

Open seat; 53.44% supported access. Rep. Betsy Fogle flipped her house seat and can win this race.

SD 34 (Northern Kansas City):

Open seat; 62.42% supported access.

Target senate races in 2028:

SD 11 (Kansas City):

Sen. Joe Nicola opposed access; 50.75% supported access.

SD 15 (Western St. Louis County):

Sen. David Gregory opposed access; 60.17% supported access.

SD 23 (St. Charles):

Sen. Adam Schnelting opposed access; 56.92% supported access.

WHY BREAKING SUPERMAJORITY MATTERS

Ending the anti-reproductive healthcare supermajorities would immediately reshape Missouri politics and open pathways to durable reproductive freedom. The impacts would be profound:

Ballot initiative protections:

Prevent the legislature from nullifying voter-passed initiatives and restricting the citizen-led process.

Preserving senate filibuster rules:

Keep tools that allow debate and can block extreme legislation.

Maintaining emergency brake tools:

Retain the ability to delay legislation for 24 hours, creating space to mobilize opposition.

Restoring the Governor's veto power:

Once supermajorities are broken, the veto becomes meaningful again, making the Governor's race viable for pro-choice candidates.

Leveraging anti-reproductive healthcare divisions:

Every seat gained weakens extremists' control and creates opportunities for moderates to side with reproductive rights advocates.

WHY INVEST IN ACCESS MO
