

## Waiver/Limitation Of Liability Notice

Now, for good consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

The Attendee or Participant desires to enroll in one or more of the TruthLoveAndFreedom Services and engage in Activities on location related to such Service.

1.
