1. Purpose

- Achieve value for money while considering the broader impact on the community and environment.

5. Roles and Responsibilities

5.1 Procurement Manager

- Procurement planning and activities.
- Develops and maintains relationships with local suppliers.

5.2 Procurement Officers

- Conduct procurement activities in line with this policy.
- v Evaluate and give preference to local suppliers during the procurement process.

5.3 Department Heads

- Procurement decisions.
- Promote awareness of the benefits of local regional procurement.

5.4 Suppliers

Understand and comply with the requirements of this policy when engaging in business with CSE Consulting Queensland.

6. Procurement Procedures

6.1 Planning

- dentify opportunities for local procurement during the planning stages of procurement activities.
- Assess the capability and capacity of local suppliers to meet the requirements.

6.2 Market Engagement

- Actively seek and encourage participation from local suppliers through market research, advertising, and supplier forums.
- Provide clear and accessible information to local suppliers about procurement opportunities and requirements.

6.3 Supplier Selection

- Give preference to local suppliers, provided they can deliver value for money and meet the required standards.
- Include criteria in evaluation processes that consider the economic, social, and environmental benefits of sourcing locally.

6.4 Contracting

- Property Ensure contracts with local suppliers include fair terms and conditions.
- Support local suppliers in understanding and meeting contractual requirements.

6.5 Performance Monitoring

- Regularly review the performance of local suppliers to ensure they meet quality, delivery, and compliance standards.
- Provide feedback and support to help local suppliers improve and grow their capabilities.

- Prioritize suppliers who demonstrate sustainable practices and social responsibility.
- Procurement activities do not harm the environment and support the well-being of the local community.

8. Compliance and Reporting

9. Review and Improvement

- This policy will be reviewed annually to ensure it remains effective and aligned with organizational and regional goals.
